# INDIANA BOARD OF TAX REVIEW Small Claims Final Determination Findings and Conclusions

The Indiana Board of Tax Review ("Board") issues this determination, finding and concluding as follows:

## **PROCEDURAL HISTORY**

- 1. Nowacki contested the 2013 assessment of his property located at 4826 W. 29<sup>th</sup> Avenue in Gary. The Lake County Property Tax Assessment Board of Appeals ("PTABOA") issued a determination valuing the vacant lot at \$2,200.
- 2. Nowacki filed a Form 131 petition with the Board and elected to proceed under our small claims procedures. On August 20, 2018, Ellen Yuhan, our designated administrative law judge ("ALJ"), held a hearing on Nowacki's petition. Neither she nor the Board inspected the property.
- 3. Nowacki appeared pro se. The Assessor appeared by Joseph E. James and Robert W. Metz, his Hearing Officers. They were all sworn as witnesses.

## **BURDEN OF PROOF**

- 3. Generally, a taxpayer seeking review of an assessing official's determination has the burden of proof. Indiana Code § 6-1.1-15-17.2 creates an exception to that general rule and assigns the burden of proof to the assessor in two circumstances—where the assessment under appeal represents an increase of more than 5% over the prior year's assessment, or where it is above the level determined in a taxpayer's successful appeal of the prior year's assessment. I.C. § 6-1.1-15-17.2(b) and (d).
- 4. Here, there was no change in the property's assessment from 2012 to 2013. Nowacki therefore bears the burden of proof.

## SUMMARY OF CONTENTIONS

- 5. Nowacki's case:
  - a. Nowacki acquired the property at an auction attended by hundreds of willing and able bidders for the minimum bid of \$100. None of the bidders had an interest in this property because of the high assessment. He contends that high tax rates are driving property owners from their homes, allowing the city to acquire the properties and arrange for political insiders to market the properties while the city maintains ownership. *Nowacki testimony*.
  - b. The Property Record Card shows the neighborhood life cycle as static, but the property's assessments have decreased from \$3,600 down to \$1,900. This clearly shows the area was declining from 2010 to 2018. *Nowacki testimony; Pet'r Exs. 1, 2.*
  - c. The property's assessments have never been correct. They were not correct in 2010, 2012, 2013, or today. If its assessments had been accurate, the property would not have churned through the tax system for 30 years. Nowacki contends a fair market value for this property is \$900. *Nowacki testimony*.
- 6. The Assessor's case:
  - a. The Assessor contends that Nowacki provided no market evidence to support his requested valuation for 2013, and he recommends no change to the assessment. *James testimony*.

#### ANALYSIS

- 7. Nowacki failed to make a prima facie case for reducing the property's 2013 assessment. The Board reached this decision for the following reasons:
  - a. The goal of Indiana's real property assessment system is to arrive at an assessment reflecting the property's true tax value. 50 IAC 2.4-1-1(c); 2011 REAL PROPERTY

ASSESSMENT MANUAL at 3. "True tax value" does not mean "fair market value" or "the value of the property to the user." I.C. § 6-1.1-31-6(c), (e). It is instead determined under the rules of the Department of Local Government Finance ("DLGF"). I.C. § 6-1.1-31-5(a); I.C. § 6-1.1-31-6(f). The DLGF defines "true tax value" as "market value in use," which it in turn defines as "[t]he market value-in-use of a property for its current use, as reflected by the utility received by the owner or by a similar user, from the property." MANUAL at 2.

- b. All three standard appraisal approaches—the cost, sales-comparison, and income approaches—are "appropriate for determining true tax value." MANUAL at 2. In an assessment appeal, parties may offer any evidence relevant to a property's true tax value, including appraisals prepared in accordance with generally recognized appraisal principles. *Id.* at 3; *see also Eckerling v. Wayne Twp. Ass'r*, 841 N.E.2d 674, 678 (Ind. Tax Ct. 2006) (reiterating that a market value-in-use appraisal that complies with the Uniform Standards of Professional Appraisal Practice is the most effective method for rebutting the presumption that an assessment is correct). Regardless of the appraisal method used, a party must relate its evidence to the relevant valuation date. *Long v. Wayne Twp. Ass'r*, 821 N.E.2d 466, 471 (Ind. Tax Ct. 2005). Otherwise, the evidence lacks probative value. *Id.* For 2013, the valuation date was March 1, 2013. Ind. Code § 6-1.1-2-1.5(a).
- c. Nowacki contends the property's 2013 assessment should be \$900, but he failed to present any probative market-based evidence to support that value. Statements that are unsupported by probative evidence are conclusory and of no value to the Board in making its determination. *Whitley Products, Inc. v. State Bd. of Tax Comm'rs*, 704 N.E.2d 1113, 1118 (Ind. Tax Ct. 1998).
- d. We also give no weight to his claims regarding the property's decreasing assessment. The Assessor's decision to decrease the property's assessment from 2010 to 2018 does not prove that its 2013 assessment was incorrect. As the Tax Court has explained, "each tax year—and each appeal process—stands alone." *Fisher v. Carroll Cnty. Ass'r*, 74 N.E. 3d 582 (Ind. Tax Ct. 2017). Evidence of a property's assessment in one year, therefore, has little bearing on its true tax value in another. *See, e.g., Fleet Supply, Inc. v. State Bd. of Tax Comm'rs*, 747 N.E.2d 645, 650 (Ind. Tax Ct. 2001); *Barth, Inc. v. State Bd. of Tax Comm'rs*, 699 N.E.2d 800, 805 n. 14 (Ind. Tax Ct. 1998).
- e. To the extent Nowacki was asserting that his purchase price of \$100 reflects the property's correct value, we disagree. The purchase price of a property can be the best evidence of a property's value. *Hubler Realty Co. v. Hendricks Co. Ass'r*, 938 N.E.2d 311, 315 (Ind. Tax Ct. 2010). Here, however, Nowacki failed to prove that the sale met the requirements of an open-market, arm's-length transaction. Nor did he attempt to relate the purchase price to the valuation date. Consequently, the purchase price is not probative evidence of the property's market value-in-use.

f. Because Nowacki offered no probative market-based evidence to demonstrate the property's correct market value-in-use, he failed to make a prima facie case for a lower assessment. Where a Petitioner has not supported his claim with probative evidence, the Respondent's duty to support the assessment with substantial evidence is not triggered. *Lacy Diversified Indus. v. Dep't of Local Gov't Fin.*, 799 N.E.2d 1215, 1221-1222 (Ind. Tax Ct. 2003).

## FINAL DETERMINATION

In accordance with the above findings of fact and conclusions of law, we find for the Assessor and order no change to the property's 2013 assessment.
