**c. Review of ALJ Decisions and Orders**

“The Administrative Law Judge’s Order Disposing of the proceeding becomes a final order when affirmed under [IC 4-21.5-3-29].” IC 4-21.5-3-27(a). Votes Required.

- i. ICRC/Michelle Radford v. James and Kun Zheng (HOfs21080289)

Submitted to the Commission October 20, 2022

The Administrative Law Judge granted the Complainant’s Motion To Dismiss due to the failure of the Aggrieved Person’s to communicate with the Complainant regarding the case, which has lead to Aggrieved Person missing hearings such as the September 20, 2022 Prehearing Conference. The complaint should be dismissed with prejudice. **The objection period in this matter has closed.**

- ii. ICRC/Tajuana Hill v. Meridian Towers Private Residences Association, Inc. d/b/a The Modern, and Kirkpatrick Management Company, Inc. (HOra22050208)

Submitted to the Commission October 17, 2022

The ALJ dismisses Respondent’s Notice of Election as far as moving this matter out of the administrative forum on September 21, 2022, because it did not state that the parties agreed to election regarding the ICRC claim. On October 7, 2022, Complainants filed an Issuance of Corrected Finding Letter Report, which had attached to it a Revised Notice Of Finding and Issuance Of Charge which corrected the error regarding the probable cause finding. At the end of it the ICRC made a probable cause

finding that a discriminatory practice occurred as alleged regarding the ICRC claim. The Complainants refiled their Notice of Election on October 15, 2022. No hearings have been scheduled and the Respondents have no objection. **The objection period in this matter has closed.**

- iii. Joshua Scully v. Matey's Bar and Grill (PAra19050286)  
Submitted to the Commission October 24, 2022

The Administrative Law Judge orders that the Respondent must cease and desist from discriminating against people based on race in the protected area of public accommodation and lists the steps the Respondent must take to show and prove compliance with this Order. **The objection period in this matter has closed.**

- iv. ICRC/Denise Wilson v. Premium Asset Services, LLC.  
(HOha22060285)

Submitted to the Commission October 11, 2022

The Administrative Law Judge denies moving the Complaint of Discrimination under the ICRL out of the administrative forum, with deadlines set in the 09/07/22 Initial Prehearing Conference Order still in effect. The Complaint of Discrimination under the IFHA is Dismissed With Prejudice, which will result in a bifurcation of the proceedings that will be addressed at the pretrial conference with the parties to determine their intent before a final dismissal is issued. **The objection period in this matter has closed.**

- v. ICRC/Denise Wilson v. Premium Asset Services, LLC (HOha22060285)

Submitted to the Commission October 21, 2022

The Administrative Law Judge grants the Joint Notice Of Election filed with the OALP, and the Complaint of Discrimination under the ICRL is Dismissed, Without Prejudice. **The objection period in this matter has closed.**

- vi. ICRC/Marrazzo v. NTS Development Company and The Lakes, LLC (HOha22070347)

Submitted to the Commission on November 3, 2022

The Administrative Law Judge grants the Notice Of Election, and the Complaint Of Discrimination under both the ICRL and the IFHA is Dismissed With Prejudice. **The objection period in this matter closes November 28<sup>th</sup>. NO vote at this time.**
