- i. Laticia Brown, o/b/o A.T. Jr. v. Richland-Bean Blossom Community School Corporation (Edgewood Intermediate School) (EDra23020144)  
Respondents, by counsel, have filed a Motion To Dismiss the Complainant's Amended Complainant filed on behalf of the Complainant's minor child, due to their failure to comply with the Claims Against Public Schools Act (“CAPSA”), Ind. Code Section 34-13-3-5 et. seq before filing this complaint, to wit they failed to satisfy certain notice requirements, specifically failing to submit “a written notice to the public school and the governing body

or the equivalent authority for a charter school that notifies them of alleged violation of law and indicates a proposed remedy. “

### **c. Review of ALJ Decisions and Orders**

“The Administrative Law Judge’s Order Disposing of the proceeding becomes a final order when affirmed under [IC 4-21.5-3-29].” IC 4-21.5-3-27(a). Votes Required.

Submitted to the Commission April 5, 2023

The Administrative Law Judge granted in part, and denied in part a Notice Of Election filed by the Respondent S & L Enterprises I, LLC’s attorney on April 5, 2023. While the Complaint of Discrimination against the Respondent S & L Enterprises I, LLC, is dismissed, the Notice is not effective in moving the entire complaint out of this administrative forum. The deadlines set in the March 30, 2023 Initial Prehearing Conference Order still applies to this claim. **The objection period in this matter has closed.**

- ii. Aaron Abadi v. Apple, Inc. (PAha21090390)

Submitted to the Commission May 4, 2023

The Administrative Law Judge in this matter granted the Respondent's Motion For Summary Judgment as the issues brought up in the complaint by the Complainant are no longer relevant but moot. The complaint is dismissed with prejudice. **The object period in this matter has closed.**

- iii. ICRC/Teresa Sparrow v. Advantix Property Management (HOha23010064)

The Administrative Law Judge in this matter DISMISSED, with prejudice, the Complaint of Discrimination under the IFHA against the Respondent, but did not move the Complaint Of Discrimination under the ICRL out of the administrative forum. **The objection period in this matter has not yet closed, so no action is required to be taken at this time.**

- iv. Jennifer Marcum (Haler) v. Wayzata Home Products, LLC (EMha20020083)

The Administrative Law Judge in this matter DISMISSED, with prejudice, the Complainant's Complaint by issuing a Default Order on July 7, 2022. **The objection period in this matter has closed.**
