- VIII. Committee Reports: The review of the committee reports is tabled for the next subsequent meeting. A quorum was not established.
  - a) Review of Maternal Health Seminar with the Indiana Department of Health's Maternal & Child Division (IDH)
    - ICW and IDH collaborated on an all-encompassing panel discussion about breaking down the barriers within maternal healthcare titled, "Your Voice, Your Story." The panel featured five of Indiana's maternal and child healthcare professionals dedicated to improving the health of women during pregnancy, childbirth, and the postnatal period.
    - The RIO investment from the November and December 2023 statewide seminar campaign was shared.
    - The seminar reached South Bend, New Albany, Evansville, Terra Haute, Fort Wayne, Elkhart, Northwest Indiana, and Indianapolis.
  - b) ICW Subcommittees: where do we go from here?
    - Discussion was held on the completion of each subcommittee's task from 2022-2023, and what
      areas of focus are to be continued. A proposal was presented to vote at the subsequent meeting
      which subcommittees will be continued.
    - Financial Independence
      - Affordable and accessible childcare in Indiana has been the primary focus of this subcommittee.
      - In 2022, the subcommittee met with the Michigan Women's Commission (MWC) to learn more about their innovative MI Tri-Share Child Care (Tri-Share) approach to

- increase high-quality, affordable child care for working families. MWC introduced a mirror program occurring in Noble County, IN by Noble County's Thrive by 5.
- In 2023, the subcommittee met with Noble County's Thrive by 5 to discuss their <u>Tri-Share</u> program. Although Noble County's Thrive by 5 received support from partners and stakeholders, the infrastructure and workforce shortage in childcare remains a dilemma.
- Infant and Maternal Mortality
  - Discussion was held on continuing the focus on infant and maternal mortality.
- Women in Public Service
  - Discussion was held to support and promote other entities and their programs.
- **IX.** New business: No new business was presented.
- X. Commissioners' Comments: Sen. Yoder presented an overview of the Period Action Day at the Statehouse.
