



Instructions for Submitting Reports to IDEM's Office of Water Quality

The Compliance Branch of IDEM's Office of Water Quality (OWQ) routinely receives reports at two email addresses: wwReports@idem.IN.gov and wwViolationResponse@idem.IN.gov. Emails with blank or vague subject lines significantly delay OWQ's processing time. Please help OWQ work efficiently by typing your email subject line as shown in the table below. *Please note that OWQ no longer accepts reports via fax.*

- ▶ **If you are submitting reports to wwReports@idem.IN.gov**, please type your email subject line as follows:

Report Being Submitted	What to Type in the Email Subject Line
Anticipated Bypass/Overflow Event	Your Permit # Anticipated Bypass/Overflow
Bypass/Overflow Incident Report (State Form 48373)	Your Permit # Bypass/Overflow
Flow Meter Calibrations	Your Permit # Flow Meter Calibration
Noncompliance 24-Hour Notification Reports (State Form 52415)	Your Permit # 24-hour Noncompliance
Notice of Change (of responsible party/CO)	Your Permit # Notice of Change
Permit Compliance Schedule Progress Reports	Your Permit # Compliance Schedule (and the pollutant name, such as Phosphorus or Mercury)
	Your Permit # Progress Report
	Your Permit # Completion of Construction
Pretreatment Reports (of any kind)	Your Permit # Pretreatment
Streamlined Mercury Variance Report	Your Permit # SMV
Toxicity Reduction Evaluation Plans and Progress Reports	Your Permit # TRE
Whole Effluent Toxicity Testing Reports	Your Permit # WETT

Examples: IN0012345 Anticipated Bypass/Overflow and IN0012345 Compliance Schedule Mercury

- ▶ **If you are submitting DMR QA reports**, send them to DMRQA@idem.IN.gov
- ▶ **If you are emailing a Noncompliance Letter response** to wwViolationResponse@idem.IN.gov, please type your email subject line as follows: Your Permit #, Response, Your Town/Company Name

Example: IN0012345 Response City of Indianapolis

Note: Feel free to attach more than one report to your email if they are the same type of report for the same permit. For example, if you are submitting multiple bypass/overflow incident reports for the same permit, you may attach all of them to one email. However, please do not attach different types of reports to the same email. For example, if you have a 24-hour noncompliance report and a bypass/overflow incident report, please email them in separate emails, and type each email subject line as set forth above.
