Description:

- Rumpke of Indiana, LLC, submitted an application to the Indiana Department of Environmental Management (IDEM) on Jan. 27, 2021 (VFC #[83102219](#)). The application is for a major modification at the Medora Sanitary Landfill, located at 546 South County Road 870 West in Medora, Jackson County (SW Program ID 36-01). Additional information was received on April 8, 2021 (VFC #[83140621](#)) and June 17, 2021 (VFC #[83170719](#)).
- The Medora Landfill property is owned and operated by Rumpke of Indiana, LLC.
- A major modification is defined in 329 IAC 10-2-109 as any increase in a permitted solid waste land disposal facility that would:
 - (1) Increase the permitted capacity to process or dispose of solid waste by the lesser of:
 - (A) More than 10%; or
 - (B) 500,000 cubic yards; or
 - (2) Increase the area within the permitted solid waste boundary by more than 1 acre.
- This major modification application proposes:
 - A vertical expansion;
 - A modified subgrade plan for the remaining undeveloped landfill area of approximately 49.4 acres, including an alternative one percent minimum base liner grade and additional sump for Cells 5, 6 and 7;
 - A modified gas collection and control system (GCCS) for the proposed vertical expansion area; and
 - Optional leachate tanks as needed to support approved leachate storage basins.
- The increase in airspace resulting from the proposed vertical expansion and minor base liner modifications is approximately 8,173,000 net cubic yards.
- The landfill is permitted for 174.1 acres approved for filling. Approximately 124.7 acres have currently received waste with 41.3 acres certified closed, 83.4 acres open, and approximately 49.4 acres undeveloped.
- The landfill may receive waste types including municipal solid waste, commercial solid waste, construction/demolition waste, small quantity generator waste, industrial solid waste, non-hazardous sludge and pollution control waste, asbestos containing materials, liquid waste for solidification, and any other solid waste authorized by the facility permit issued on Dec. 15, 2017 (VFC #[80575760](#)).
- The landfill cannot receive hazardous waste.
- The landfill receives approximately 1,500 tons of waste per day.

IDEM's Role:

- IDEM is responsible for protecting human health and the environment while providing for safe industrial, agricultural, commercial, and governmental operations vital to a prosperous economy.
- The Office of Land Quality, Permits Branch, Solid Waste Permits Section is involved in regulating, monitoring, permitting, and inspecting Rumpke Medora Landfill.
- IDEM will review the application to determine if it includes all the required information and determine if the information provided is adequate for technical compliance.

Citizen's Role:

- IDEM is accepting written comments and questions from the public through Sept. 23, 2021.
- The public meeting is Aug. 24, 2021, from 6-8 p.m. EDT, at the Carr Township Conservation Club, 7709 West County Road 350 South, Medora, Ind. 47260.
 - Comments will also be received from all interested parties at the meeting, in either oral or written form.
 - Persons presenting oral testimony are requested to submit a written copy of their statements. Written statements may be submitted up to ten days following the meeting.
