NOTICE OF PUBLIC MEETING

Preliminary Findings Regarding a
Part 70 Operating Permit Renewal

for Heidelberg Materials US Cement LLC in Clark County

Part 70 Operating Permit Renewal No.: T019-46627-00008

The Indiana Department of Environmental Management (IDEM) has received an application from Heidelberg Materials US Cement LLC, located at 301 Highway 31, Sellersburg, Indiana 47172, for a Part 70 Operating Permit. IDEM's Office of Air Quality (OAQ) issues renewals of this type of permit to regulate the operation of existing sources and modifications at existing sources that release air pollutants.

On February 27, 2024, the Office of Air Quality (OAQ) had a notice posted on IDEM's website (<https://www.in.gov/idem/public-notice/>) stating that the draft Part 70 Operating Permit for Heidelberg Materials US Cement LLC had been proposed for this operation and provided information on how the public could review the proposed permit and other documentation. Due to several comments received by IDEM from interested parties, a public meeting will be held on April 30, 2024 to discuss air permitting for Heidelberg Materials US Cement LLC.

1. The public meeting will be conducted using the Microsoft Teams software application. Participants will be able to join the meeting without downloading the Teams application.
2. Participants, especially those wishing to speak, should also add their name, when prompted, while joining or signing into the meeting.
3. When participants join the meeting, they will be placed in a virtual waiting room until the public meeting begins. Anyone wishing to speak during the meeting should complete the Speaker Form using the instructions available in the waiting room. The form link and waiting room will be available about one hour before the scheduled start of the meeting.
4. All participants will be muted when they join the meeting. IDEM, OAQ will unmute individuals to speak when called upon by the IDEM, OAQ public meeting officer.
5. It is recommended that anyone speaking during the meeting use headphones with a microphone if possible.
6. Participants will only be able to send chat messages to the IDEM, OAQ staff conducting the meeting. The chat feature will only be used for participants who have procedural questions or need technical assistance during the meeting. Chat messages will not become part of the record and will not be considered comments on the draft permit documents.
7. Participants with documents, presentations or other materials will not be able to submit them during the meeting. These materials should be submitted to IDEM, OAQ during the public comment period pursuant to the instructions below on how to submit comments and supporting documents.

What will happen at the meeting?

IDEM staff will describe the draft Heidelberg US Cement LLC air permit and answer questions from citizens in an informal setting. The virtual public meeting will not include formal presentations, but will give the public an opportunity to ask questions and discuss air pollution concerns with IDEM staff.

How can you participate in this process?

Written comments and supporting documentation can be submitted to IDEM before the end of the public notice period. The public notice period will end on Monday, May 6, 2024. All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality

issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor or noise. For such issues, please contact your local officials. If you do not want to comment, but would like to be added to IDEM's mailing list to receive notice of future action related to this permit application, please contact IDEM. 

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the address indicated above and will also be sent to the local library indicated above, the IDEM Regional Office indicated above, and the IDEM public file room on the 12th floor of the Indiana Government Center North, 100 N. Senate Avenue, Indianapolis, Indiana 46204-2251.
