NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding a
Significant Revision to a
Federally Enforceable State Operating Permit (FESOP)
for Tuscany Motor Company in Elkhart County
Significant Permit Revision No.: 039-48890-00767

The Indiana Department of Environmental Management (IDEM) has received an application from Tuscany Motor Company, located at 2500 Banks Ct, Elkhart, IN 46514, for a significant revision of its FESOP issued on September 19, 2022. If approved by IDEM's Office of Air Quality (OAQ), this proposed revision would allow Tuscany Motor Company to make certain changes at its existing source. Tuscany Motor Company has submitted an application related to the following:

- (1) The source is requesting to install a hydro-dip graphics application system, also known as water transfer printing, to the permit. Hydro dipping is a process used to apply intricate designs, patterns, or textures to three-dimensional objects using a patterned film that floats on the surface of a water bath. The system will consist of a 84"L x 50"W x 30"D open-top water tank and an activator spray system. The film itself will contain no VOC or HAP. The activator is a VOC-based material akin to solvent. This process will emit VOC, particulate, and HAPs. Additional HAPs limits will be added to the permit so the source remains a FESOP.
- (2) The HVLP paint booths PB1, PB2, and PB3 will begin refinishing automobiles and using new coatings. The requirements of 326 IAC 8-10 (Automobile Refinishing) will be added to the permit for these units. As a result of the new coatings, which will contain HAPs that are subject to 40 CFR 63, Subpart HHHHHH, PB1, PB2, and PB3 will become subject to NESHAP HHHHHH, and the maximum throughput for PB1, PB2, and PB3 will increase from 0.92 gal/unit to 0.94 gal/unit, each.

The HVLP paint booths PB4, PB5, and PB6 and the new hydro-dip graphics application system will continue to coat vehicle kits and will not begin refinishing automobiles. Additionally, PB4, PB5, and PB6 will not use new coatings that are subject to NESHAP HHHHHH.

- (4) The three existing, exempt gun washers will be added to the permit.

The applicant intends to construct and operate new equipment that will emit air pollutants; therefore, the permit contains new or different permit conditions. In addition, some conditions from previously issued permits/approvals have been corrected, changed, or removed. These corrections, changes, and removals may include Title I changes (e.g., changes that add or modify synthetic minor emission limits). The potential to emit regulated air pollutants will continue to be limited to less than the Title V major threshold levels. IDEM has reviewed this application and has developed preliminary findings, consisting of a draft permit and several supporting documents, which would allow the applicant to make this change.

How can you participate in this process?

This notice is posted on IDEM's website (<https://www.in.gov/idem/public-notices/>). The date that this notice is posted on IDEM's website marks the beginning of a 30-day public comment period. If the 30th day of the comment period falls on a day when IDEM offices are closed for business, all comments must be postmarked or delivered in person on the next business day that IDEM is open.

You may request that IDEM hold a public hearing about this draft permit. If adverse comments concerning the **air pollution impact** of this draft permit are received, with a request for a public hearing, IDEM will decide whether or not to hold a public hearing. IDEM could also decide to hold a public meeting instead of, or in addition to, a public hearing. If IDEM decides to conduct a public hearing and/or public meeting, IDEM will post a separate announcement of the date, time, and location of that public hearing and/or public meeting on IDEM's website (<https://www.in.gov/idem/public-notices/>). At a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor, or noise. For such issues, please contact your local officials.

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the addresses indicated above and will also be sent to the local library indicated above.
