On June 25, 2025, Living Rooted LLC dba Roann Compost submitted an application for an Industrial Waste Product Marketing and Distribution Permit. A request for additional information was sent on August 1, 2025, indicating hydraulic conductivity tests were required for the compost pad and detention pond identified in the application. An email was sent to the facility on November 25, 2025, explaining that due to statutory deadlines, if the facility was unable to provide the hydraulic conductivity tests by December 9, 2025, they would need to withdraw the application and resubmit once they have the requested information. On December 8, 2025, Mr. Rick Duff from Roann Compost requested the application be withdrawn. The request explained that hydraulic conductivity tests were delayed due to cold weather and snow, therefore, would not be completed by December 9, 2025. ## APPEAL PROCEDURES

If you wish to challenge this decision, IC 13-15-6-1 and IC 4-21.5-3 require that you file a Petition for Administrative Review with the Office of Administrative Law Proceeding (OALP). If you seek to have the effectiveness of the permit stayed during the Administrative Review, you must also file a Petition for Stay (see 315 IAC 1-3-2). The Petition(s) must be submitted to the OALP at the address below within 15 days (18 days if receiving this notice by U.S Mail) of the date of publication of this Notice:

The Petition(s) must include facts demonstrating that you are either the applicant, a person aggrieved or adversely affected by the decision or otherwise entitled to review by law. Identifying the permit, decision, or other order for which you seek review by permit number, name of the applicant, location, or date of this notice will expedite review of the petition. Additionally, IC 13-15-6-2 and 315 IAC 1-3-2 require that your Petition include:

- 1. the name, address, and telephone number of the person making the request;
- 2. the interest of the person making the request;
- identification of any persons represented by the person making the request;
- 4. the reasons, with particularity, for the request;
- 5. the issues, with particularity, for the request;
- 6. identification of the terms and conditions which, in the judgment of the person making the request, would be appropriate in the case in question to satisfy the

- requirements of the law governing documents of the type granted or denied by the Commissioner's action; and
- 7. a copy of the pertinent portions of the permit, decision, or other order for which you seek review, at a minimum, the portion of the Commissioner's action that identifies the person to whom the action is directed and the identification number of the action.

Pursuant to IC 4-21.5-3-17, any document serving as a petition for review or review and stay must be filed with the OALP. Filing of such a document is complete on the earliest of the following dates:

- 1. the date on which the petition is delivered in person to the OALP, by the close-of-business:
- 2. the date of the postmark on the envelope containing the petition, if the petition is mailed by United States mail; or
- 3. the date on which the petition is deposited with a private carrier, as shown by a receipt issued by the carrier, if the petition is sent by private carrier;

If you do not provide a written request to the OALP, you will no longer be notified of any proceedings pertaining to this decision.
