NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding a Minor Modification to a
Part 70 Operating Permit

for Molding Products, LLC in St. Joseph County

Minor Permit Modification No.: 141-49932-00091

The Indiana Department of Environmental Management (IDEM) has received an application from Molding Products, LLC, located at 1545 South Olive Street, South Bend, Indiana 46619, for a minor modification of its Part 70 Operating Permit issued on June 14, 2022. If approved by IDEM's Office of Air Quality (OAQ), this proposed modification would allow Molding Products, LLC to make certain changes at its existing source. Molding Products, LLC has applied to related to the following:

- (a) The source is requesting to update the ventilation information for various resin storage and holding tanks listed in the section A.3 (Insignificant Activities) (c) and (f) of the existing permit. These units previously exhausted indoors, but have been modified to now exhaust outdoors. The holding tanks are subject to breathing losses and in the case of the resin tanks, the vapor loss would be styrene, a flammable chemical. The plant would like to vent the tanks outside to prevent the accumulation of flammable vapors inside of the facility.
- (b) The source is requesting to add a second control device (dust collector) in the room where SMC #3 is operated. This control device will not be directly tied to SMC #3 but will serve as general ventilation control for the room to control general workplace dust as well as to improve general hygiene at the facility for employee safety.
- (c) Existing units SMC machine #1 and #2 were included in the permit and controlled by a baghouse. The chopper portion of these machines emits particulate matter. The PTE calculations are being updated to reflect PM emissions from this process, since these were not previously included.

The applicant intends to operate new equipment that will emit air pollutants; therefore, the permit contains new or different permit conditions. In addition, some conditions from previously issued permits/approvals have been corrected, changed, or removed. These corrections, changes, and removals may include Title I changes (e.g., changes that add or modify synthetic minor emission limits). IDEM has reviewed this application and has developed preliminary findings, consisting of a draft permit and several supporting documents, which would allow the applicant to make this change.

How can you participate in this process?

This notice is posted on IDEM's website (<https://www.in.gov/idem/public-notices/>). The date that this notice is posted on IDEM's website marks the beginning of a 30-day public comment period. If the 30th day of the comment period falls on a day when IDEM offices are closed for business, all comments must be postmarked or delivered in person on the next business day that IDEM is open.

You may request that IDEM hold a public hearing about this draft permit by sending a written request to IDEM at the address below. If adverse comments concerning the **air pollution impact** of this draft permit are received, with a request for a public hearing, IDEM will decide whether or not to hold a public hearing. IDEM could also decide to hold a public meeting instead of, or in addition to, a public hearing. If IDEM decides to conduct a public hearing and/or public meeting, IDEM will post a separate announcement of the date, time, and location of that public hearing and/or public meeting on IDEM's website (<https://www.in.gov/idem/public-notices/>). At a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

In order to notify you of our final decision regarding this permitting action, your U.S. mailing address must be submitted with all comments.


All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor, or noise. For such issues, please contact your local officials.

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the addresses indicated above and will also be sent to the local library indicated above.
