

On August 21, 2025, Duneland Composting and Landscaping, LLC submitted an application for a modification of an Industrial Waste Product Marketing and Distribution Permit. The modification requested a change to the design of the composting pad to allow the installation of a clay berm around the perimeter of the composting pad. A request for additional information was sent on November 14, 2025, indicating additional information was needed to complete the application. An email was sent to the facility on January 14, 2026, explaining that due to statutory deadlines, if the facility was unable to provide the requested information by January 19, 2026, the facility would need to withdraw the application and resubmit when they have the requested information. On January 14, 2026, Mr. Jeffrey Langbehn requested a withdraw of the modification application, indicating the facility intended to make additional modifications to the composting pad, and a new and updated modification would be submitted. APPEAL PROCEDURES

If you wish to challenge this decision, IC 13-15-6-1 and IC 4-21.5-3 require that you file a Petition for Administrative Review with the Office of Administrative Law Proceeding (OALP). If you seek to have the effectiveness of the permit stayed during the Administrative Review, you must also file a Petition for Stay (see 315 IAC 1-3-2). The Petition(s) must be submitted to the OALP at the address below within 15 days (18 days if receiving this notice by U.S Mail) of the date of publication of this Notice:

The Petition(s) must include facts demonstrating that you are either the applicant, a person aggrieved or adversely affected by the decision or otherwise entitled to review by law. Identifying the permit, decision, or other order for which you seek review by permit number, name of the applicant, location, or date of this notice will expedite review of the petition. Additionally, IC 13-15-6-2 and 315 IAC 1-3-2 require that your Petition include:

1. the name, address, and telephone number of the person making the request;
2. the interest of the person making the request;
3. identification of any persons represented by the person making the request;
4. the reasons, with particularity, for the request;
5. the issues, with particularity, for the request;

6. identification of the terms and conditions which, in the judgment of the person making the request, would be appropriate in the case in question to satisfy the requirements of the law governing documents of the type granted or denied by the Commissioner's action; and
7. a copy of the pertinent portions of the permit, decision, or other order for which you seek review, at a minimum, the portion of the Commissioner's action that identifies the person to whom the action is directed and the identification number of the action.

Pursuant to IC 4-21.5-3-17, any document serving as a petition for review or review and stay must be filed with the OALP. Filing of such a document is complete on the earliest of the following dates:

1. the date on which the petition is delivered in person to the OALP, by the close-of-business;
2. the date of the postmark on the envelope containing the petition, if the petition is mailed by United States mail; or
3. the date on which the petition is deposited with a private carrier, as shown by a receipt issued by the carrier, if the petition is sent by private carrier;

The OALP will provide you with notice of any pre-hearing conferences, preliminary hearings, hearings, stays, or orders regarding this decision if you submit a written request to the OALP. If you do not provide a written request to the OALP, you will no longer be notified of any proceedings pertaining to this decision.
