Our office has received your NPDES Notice of Intent (NOI) submittal for the above-referenced Indiana Department of Natural Resources abandoned mine land (AML) project. We are pleased to inform you that the submittal is sufficient to comply with the NOI requirements for 327 IAC 15-7, and that this project will be covered under the NPDES General Permit for Facilities Engaging in Mining of Coal, Coal Processing, and Reclamation Activities.

We have reviewed your request and have determined that the activities associated with it will not violate the antidegradation rules as set forth in 327 IAC 2-1.3. Our office has further determined that the request will not affect this facility's eligibility for coverage under the general permit rules outlined in 327 IAC 15-1 through 15-4 and 327 IAC 15-7, Facilities Engaged in the Mining of Coal, Coal Processing, and Reclamation Activities. Therefore, your petition to obtain permit coverage as is described in your NOI has been approved in accordance with Indiana rules promulgated under 327 IAC 15-7 and 327 IAC 2-1.3. Coverage for the facility includes all outfalls listed in **Attachment 1** to this letter and discharge limitations and monitoring requirements are set out in **Attachment 2**.

The NPDES general permit identification number assigned to this facility is referenced above. Please use this number in all correspondence regarding this NPDES general permit coverage. **Coverage shall become effective March 1, 2026**, at which time you will be required to follow all terms and conditions of 327 IAC 15-7. Coverage under 327 IAC 15-7 **will expire February 28, 2031**. In order to receive authorization to discharge beyond this expiration date, you are required to submit a renewal NOI to IDEM no later than ninety (90) days prior to the date of expiration.



One condition of your permit requires periodic reporting of several effluent parameters. You are required to submit both federal discharge monitoring reports (DMRs) and state Monthly Monitoring Reports (MMRs) on a routine basis. The MMR form can be found at <https://www.in.gov/ide/cleanwater/wastewater-compliance/wastewater-reporting-forms-notices-and-instructions/>. All NPDES permit holders are required to submit their monitoring data to IDEM using NetDMR. For more information on NetDMR, please see our website at <https://www.in.gov/ide/cleanwater/resources/netdmr/>. Also, all current agency rules, including the general NPDES permits-by-rule, 327 IAC 15, are posted at <https://www.in.gov/ide/legal/environmental-laws-and-rules/>.

Please note that IDEM is required to serve notice of its decision to accept your facility for coverage under the general permit in accordance with the requirements of 327 IAC 5-3-14. It should also be noted that any appeal must be filed under procedures outlined in IC 13-15-6, IC 4-21.5, and the enclosed Public Notice. The appeal must be initiated by filing a petition for administrative review with the Office of Administrative Law Proceedings (OALP) within fifteen (15) days of the emailing of an electronic copy of this letter or within eighteen (18) days of the mailing of this letter. In accordance with 327 IAC 15-7-7(a)(3), the following effluent limitations and monitoring requirements apply to discharges from outfalls with coal mining activities within the drainage area which contain active mining areas, coal preparation plants, and/or coal preparation plant associated areas with a new source acid mine drainage status.

- [1] These limits are applicable to discharges which occur during dry weather base flow for an outfall. This is the default set of effluent limits unless the permittee provides adequate documentation of eligibility for any alternate precipitation-based effluent limits, as set forth in Tables 2 and 3 below. At least one sampling event per month is supposed to occur during dry weather base flow conditions.

- [2] In accordance with 327 IAC 15-7-7(c)(1), the permittee may opt to apply the effluent limits and monitoring requirements in Table 2 in lieu of those in Table 1 to a discharge when the discharge flow rate exceeds the dry weather base flow when a precipitation event is less than or equal to the 10-year, 24-hour storm event on the date that the sampling occurred. The permittee must provide documentation that the discharge met the qualifications for utilizing the alternate precipitation-based effluent limits for each instance in which the permittee wishes to apply them.
- [3] The limit for settleable solids is a maximum not to be exceeded in any grab sample.

- [4] In accordance with 327 IAC 15-7-7(c)(2), the permittee may opt to apply the effluent limits and monitoring requirements in Table 3 (in lieu of those in Tables 1 and 2) to a discharge when the discharge flow rate exceeds the 10-year, 24-hour storm event on the date that the sampling occurred. The permittee must provide documentation that the discharge met the qualifications for utilizing this set of alternate precipitation-based effluent limits for each instance in which the permittee wishes to apply them.

NEW COVERAGE UNDER 327 IAC 15-7

AML SITE 131 ALMOND LAKE HIGHWALL, NPDES GENERAL PERMIT COVERAGE NO. ING040307. The project location is 2000 feet north of the intersection of CR 200S and CR 1525W on the west side of CR 1525W, near Dugger, IN (GREENE COUNTY). This abandoned mine land project will be completed to alleviate the public health, safety, and environmental hazards associated with past coal mining activities. It will consist of clearing and grubbing, backfilling highwall areas, regrading piles and embankments, improving drainage, filling, and revegetating disturbed areas. The permittee (Sun Energy Group, LLC, in association with the Department of Natural Resources Division of Reclamation) has submitted a sufficient Notice of Intent to obtain NPDES general permit coverage under 327 IAC 15-7, the NPDES general permit-by-rule for Facilities Engaged in Mining of Coal, Coal Processing, and Reclamation Activities. There will be one (1) permitted outfall associated with this project that will discharge to an unnamed water body within the Greene-Sullivan State Forest. The outfall is located in Greene County at the following GPS coordinates:

Notice of Right to Administrative Review

If you wish to challenge this permit, you must file a Petition for Administrative Review with the Office of Administrative Law Proceedings (OALP) and serve a copy of the petition upon IDEM. The requirements for filing a Petition for Administrative Review are found in IC 4-21.5-3-7, IC 13-15-6-1 and 315 IAC 1-3-2. A summary of the requirements of these laws is provided below.

A Petition for Administrative Review must be filed with the OALP within fifteen (15) days of the issuance of this notice (eighteen (18) days if you received this notice by U.S. Mail), and a copy must be served upon IDEM. Addresses are as follows:

The petition must contain the following information:

1. The name, address and telephone number of each petitioner.
2. A description of each petitioner's interest in the permit.
3. A statement of facts demonstrating that each petitioner is:
 - a. a person to whom the order is directed;
 - b. aggrieved or adversely affected by the permit; or

- c. entitled to administrative review under any law.
- 4. The reasons for the request for administrative review.
- 5. The particular legal issues proposed for review.
- 6. The alleged environmental concerns or technical deficiencies of the permit.
- 7. The permit terms and conditions that the petitioner believes would be appropriate and would comply with the law.
- 8. The identity of any persons represented by the petitioner.
- 9. The identity of the person against whom administrative review is sought.
- 10. A copy of the permit that is the basis of the petition.
- 11. A statement identifying petitioner's attorney or other representative, if any.

Failure to meet the requirements of the law with respect to a Petition for Administrative Review may result in a waiver of your right to seek administrative review of the permit. Examples are as follows:

- 1. Failure to file a Petition by the applicable deadline;
- 2. Failure to serve a copy of the Petition upon IDEM when it is filed; or
- 3. Failure to include the information required by law.

If you seek to have a permit stayed during the administrative review, you may need to file a Petition for a Stay of Effectiveness. The specific requirements for such a Petition can be found in 315 IAC 1-3-2 and 315 IAC 1-3-2.1.

Pursuant to IC 4-21.5-3-17, OALP will provide all parties with notice of any pre-hearing conferences, preliminary hearings, hearings, stays, or orders disposing of the review of this action. If you are entitled to notice under IC 4-21.5-3-5(b) and would like to obtain notices of any pre-hearing conferences, preliminary hearings, hearings, stays, or orders disposing of the review of this action without intervening in the proceeding you must submit a written request to OALP at the address above.

- (A) state the name and address of the person making the request;
- (B) identify the interest of the person making the request;

- (D) state with particularity the reasons for the request;
- (E) state with particularity the issues proposed for consideration at the hearing; and
- (F) state with particularity the reasons why the NPDES general permit rule should not be available to the discharger identified in this notice.

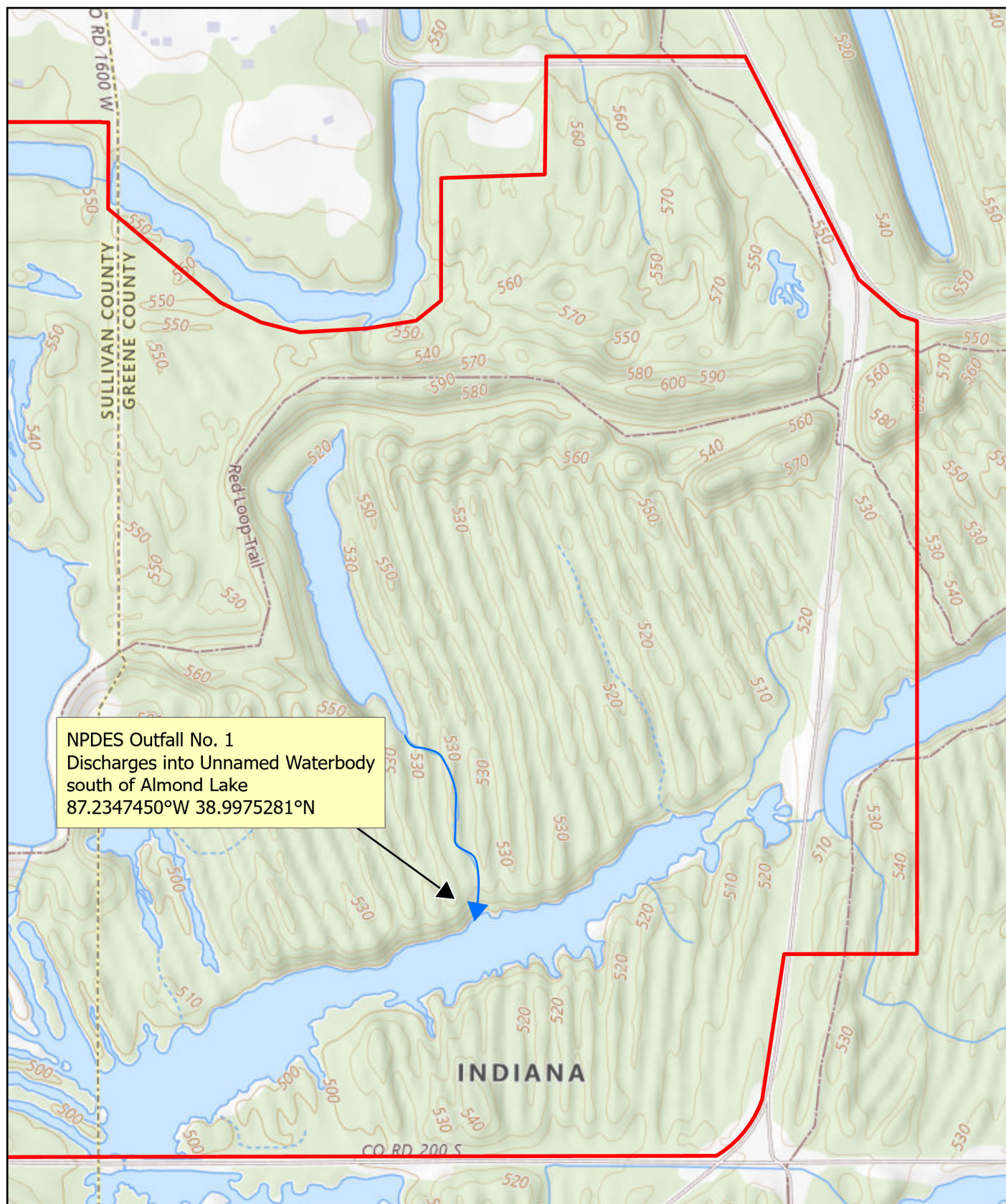
