### NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding the Renewal of a  
Part 70 Operating Permit and  
Significant Modification to a  
Part 70 Operating Permit

for Forest River, Inc., Goshen Complex in Elkhart County

Part 70 Operating Permit Renewal No.: T039-49706-00011  
Significant Source Modification No.: 039-49778-00011

The Indiana Department of Environmental Management (IDEM) has received an application from Forest River, Inc., Goshen Complex, located at 2780, 2790, 3010 College Avenue and 2405, 2012 2016, 2449, 1702, 2020, 1802, 2324, 2367, 2372, 2408, 2551, 2412, 1803, 2421 Century Drive, 2478 Supreme Court, Goshen, IN 46526, for a significant source modification and renewal of its Part 70 Operating Permit. If approved by IDEM's Office of Air Quality (OAQ), this proposed permit would allow Forest River, Inc., Goshen Complex to make certain changes at its existing source. Forest River, Inc., Goshen Complex has applied to redesignate several units, modify several units, remove several units, updating surface coating calculations to reflect actual coatings and not utilizing worst case coatings, updating the source name and address, and to update the limits provided by the BACT analysis.

The applicant intends to operate new equipment that will emit air pollutants; therefore, the permit contains new or different permit conditions. In addition, some conditions from previously issued permits/approvals have been corrected, changed, or removed. These corrections, changes, and removals may include Title I changes (e.g., changes that add or modify synthetic minor emission limits). IDEM has reviewed this application and has developed preliminary findings, consisting of a draft permit and several supporting documents, which would allow the applicant to make this change.

IDEM is aware that the welding operations and insignificant saws have been constructed and operated prior to receipt of the proper permit. IDEM is reviewing this matter and will take appropriate action. This draft permit contains provisions to bring unpermitted equipment into compliance with construction and operation permit rules.

## How can you participate in this process?

This notice is posted on IDEM's website (<https://www.in.gov/idem/public-notices/>). The date that this notice is posted on IDEM's website marks the beginning of a 30-day public comment period. If the 30<sup>th</sup> day of the comment period falls on a day when IDEM offices are closed for business, all comments must be postmarked or delivered in person on the next business day that IDEM is open.

You may request that IDEM hold a public hearing about this draft permit by sending a written request to IDEM at the address below. If adverse comments concerning the **air pollution impact** of this draft permit are received, with a request for a public hearing, IDEM will decide whether or not to hold a public hearing. IDEM could also decide to hold a public meeting instead of, or in addition to, a public hearing. If IDEM decides to conduct a public hearing and/or public meeting, IDEM will post a separate announcement of the date, time, and location of that public hearing and/or public meeting on IDEM's website (<https://www.in.gov/idem/public-notices/>). At a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

If you comment via e-mail, please include your full U.S. mailing address so that you can be added to IDEM's mailing list to receive notice of future action related to this permit. In order to notify you of our final decision regarding this permitting action, your U.S. mailing address must be submitted with all comments.

All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor, or noise. For such issues, please contact your local officials.

## What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the addresses indicated above and will also be sent to the local library indicated above.
