NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding a
Significant Modification to a
Part 70 Operating Permit

for FGF, LLC in Hendricks County

Significant Source Modification No.: 063-50342-00031
Significant Permit Modification No.: 063-50356-00031

The Indiana Department of Environmental Management (IDEM) has received an application from FGF, LLC, located at 50 Maplehurst Dr., Brownsburg, Indiana 46112, for a significant modification of its Part 70 Operating Permit issued on April 27, 2026. If approved by IDEM's Office of Air Quality (OAQ), this proposed modification would allow FGF, LLC to make certain changes at its existing source. FGF, LLC has applied to make the following changes:

1. Increase the VOC emission factor used for the donut production lines (Moline I, Moline IV, Moline V, Moline VI, and Moline VII) from 1.97 lb/ton to 4.29 lb/ton, based on source-specific stack testing conducted on October 31, 2024. The increased emission factor represents combined VOC emissions from fermentation, proofing, and frying operations under a single exhaust configuration.
2. Add VOC emission limits for the donut production lines, Moline I, Moline IV, and Moline V, in order to render the requirements of 326 IAC 8-1-6 (BACT) not applicable.
3. Remove two (2) donut production lines, identified as Moline III and Rhake, and two (2) dry ingredient scale hoppers/mixers, identified as EU-32 and EU-33.
4. Add one (1) existing transfat tank, with a maximum design capacity of 20,000 gallons, to the list of insignificant activities in the permit.

This draft permit does not contain any new equipment that would emit air pollutants; however, some conditions from previously issued permits/approvals have been corrected, changed, or removed. These corrections, changes, and removals may include Title I changes (e.g., changes that add or modify synthetic minor emission limits). This notice fulfills the public notice procedures to which those conditions are subject. IDEM has reviewed this application and has developed preliminary findings, consisting of a draft permit and several supporting documents, which would allow for these changes.

specify the five-digit permit number "50356" or the five-digit source modification number "50342" in the Permit # search field, then click the Search button at the top or bottom of the webpage.

How can you participate in this process?

This notice is posted on IDEM's website (<https://www.in.gov/idem/public-notices/>). The date that this notice is posted on IDEM's website marks the beginning of a 30-day public comment period. If the 30th day of the comment period falls on a day when IDEM offices are closed for business, all comments must be postmarked or delivered in person on the next business day that IDEM is open.

You may request that IDEM hold a public hearing about this draft permit by sending a written request to IDEM at the address below. If adverse comments concerning the **air pollution impact** of this draft permit are received, with a request for a public hearing, IDEM will decide whether or not to hold a public hearing. IDEM could also decide to hold a public meeting instead of, or in addition to, a public hearing. If IDEM decides to conduct a public hearing and/or public meeting, IDEM will post a separate announcement of the date, time, and location of that public hearing and/or public meeting on IDEM's website (<https://www.in.gov/idem/public-notices/>). At a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

In order to notify you of our final decision regarding this permitting action, your U.S. mailing address must be submitted with all comments.

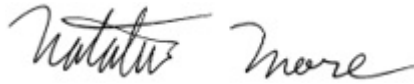
All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor, or noise. For such issues, please contact your local officials.

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the addresses indicated above and will also be sent to the local library indicated above.
