NOTICE OF 30-DAY PERIOD FOR PUBLIC COMMENT

Preliminary Findings Regarding a New Source Construction and
Part 70 Operating Permit
for Orla, LLC in Boone County

Part 70 Operating Permit No.: T 011-50034-00093

The Indiana Department of Environmental Management (IDEM) has received an application from Orla, LLC, located at 3062 West SR 32, Lebanon, IN 46052, for a new source construction and Part 70 Operating Permit. If approved by IDEM's Office of Air Quality (OAQ), this proposed permit would allow Orla, LLC to construct and operate a new stationary data center.

The applicant intends to construct and operate new equipment that will emit air pollutants. IDEM has reviewed this application, and has developed preliminary findings, consisting of a draft permit and several supporting documents, that would allow the applicant to make this change.

How can you participate in this process?

This notice is posted on IDEM's website (<https://www.in.gov/idem/public-notices/>). The date that this notice is posted on IDEM's website marks the beginning of the public comment period. IDEM will be conducting a virtual public hearing. IDEM has posted a separate announcement of the date, time, and location of the public hearing on IDEM's website (<https://www.in.gov/idem/public-notices/>). The public comment period will end on Monday, August 10, 2026. At a hearing, you will have an opportunity to submit written comments and make verbal comments. All comments must be postmarked, faxed, emailed, or delivered in person by Monday, August 10, 2026.

Comments and supporting documentation should be sent in writing to IDEM at the address below. If you comment via e-mail, please include your full U.S. mailing address so that you can be added to IDEM's mailing list to receive notice of future action related to this permit. In order to notify you of our final decision regarding this permitting action, your U.S. mailing address must be submitted with all comments.

All comments will be considered by IDEM when we make a decision to issue or deny the permit. Comments that are most likely to affect final permit decisions are those based on the rules and laws governing this permitting process (326 IAC 2), air quality issues, and technical issues. IDEM does not have legal authority to regulate zoning, odor, or noise. For such issues, please contact your local officials.

What will happen after IDEM makes a decision?

Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the addresses indicated above and will also be sent to the local library indicated above.
