- 3. Project Location:** Latitude 41.476500, Longitude -87.302140
Approximately 1500 feet north of the intersection of U.S. Highway 30 and Colorado Steet in Hobart, Lake County.
- 4. Affected Waterbodies:** Two emergent wetlands and one unnamed tributary to Sprout Creek.
- 5. Project Description:** Industrial development involving impacts to 5.49 acres of jurisdictional wetlands and 325 linear feet of stream channel with fill and excavation. Proposed mitigation is the purchase of 325 linear feet of stream credits from the Calumet Dunes Service Area of the Indiana Stream and Wetland Mitigation Program, and the purchase of 8.235 acres of emergent wetland credits from the Old City Light Mitigation Bank. **This project is unrelated to the Hobart Data Center.**

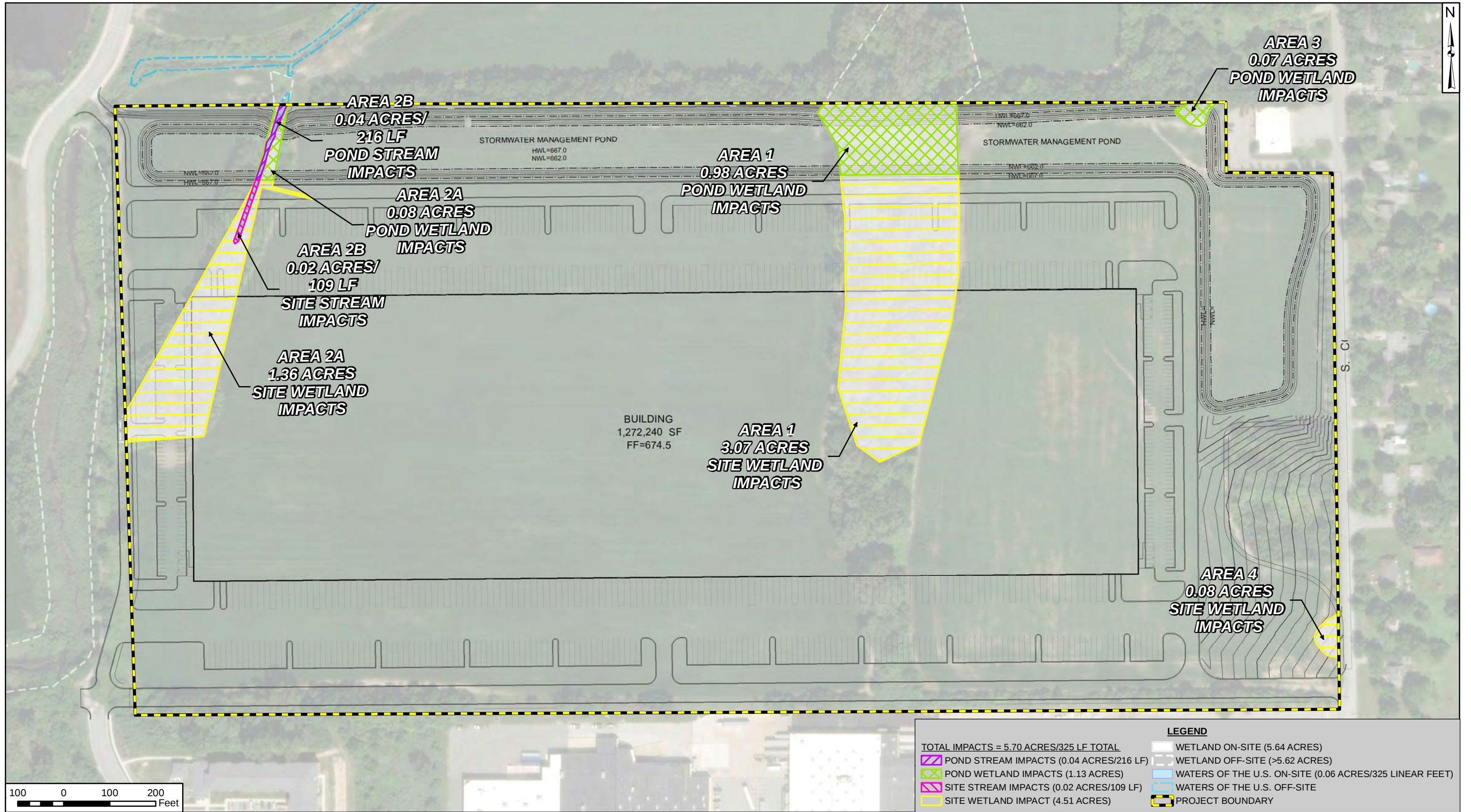

This responds to your letter dated August 3, 2022, requesting our comments on the aforementioned project.

These comments have been prepared under the authority of the Fish and Wildlife Coordination Act (16 U.S.C. 661 et. seq.) and are consistent with the intent of the National Environmental Policy Act of 1969, the Endangered Species Act of 1973, and the U. S. Fish and Wildlife Service's Mitigation Policy.

The proposed project consists of the development of warehouses and associated infrastructure on unstated acreage north of The Crossings at Hobart shopping center and west of Colorado Street. The parcel is primarily active cropland with some woodlands/possible wetlands associated with tributaries of Sprout Ditch.

ENDANGERED SPECIES

The proposed project is within the range of the Federally endangered Indiana bat (*Myotis sodalis*) and rusty patched bumble bee (*Bombus affinis*) and the threatened/proposed endangered northern long-eared bat (*Myotis septentrionalis*). However, there is no habitat for these species at the proposed project site, so we agree that the proposed project is not likely to adversely affect these endangered and threatened/proposed endangered species.

The candidate Monarch butterfly (*Danaus plexippus*) is also likely to be present. As a candidate species, the Monarch butterfly is not afforded legal protection under the authorities of the Endangered Species Act, and we have no specific comments/recommendations concerning this species at this time.

This precludes the need for further consultation on this project as required under Section 7 of the Endangered Species Act of 1973, as amended. However, should new information arise pertaining to project plans or a revised species list be published, it will be necessary for the Federal agency to reinitiate consultation.
