- **Public Availability Session** scheduled **Tuesday, November 29, 2016** at the **Wheatfield Town Hall** from **5:30-7:30 p.m. CST**. This event will not include a formal meeting/presentation. Residents are welcome to visit between 5:30 and 7:30 p.m. to view informational posters and ask questions.
- The air sparge/soil vapor extraction remediation system was delivered and installed the week of June 13th. Please refer to [A Citizen's Guide to Soil Vapor Extraction and Air Sparging](#) for detailed information about the remediation technology.
- During the fourth quarter 2015 ground water sampling event, benzene impacts were identified in a monitoring well north of Hershman Drive. As a result, this area was further evaluated and a limited area of dissolved benzene was identified. Several new monitoring wells were installed and drinking water wells along Fyda Place were retested during January and February 2016. Benzene contamination was not detected in drinking water wells north of Hershman Drive. Area monitoring wells will continue to be tested on a routine basis to ensure that residents are not exposed to dissolved petroleum contamination.

Summary

On July 2, 2012, the Indiana Department of Environmental Management (IDEM) received a report of a release from the underground storage tank system (UST) at the T-Mart Marathon Station located at 3772 West State Road 10, Wheatfield, Indiana.

Since October 2012, several investigations have been completed in order to delineate the nature and extent of soil and ground water contamination. The investigations resulted in several homes being placed on drinking water filtration systems, the installation of a vapor mitigation system at the T-Mart Marathon convenience store, and an ongoing drinking water monitoring program.

On January 16, 2015, IDEM approved the use of an air sparge (AS) and soil vapor extraction (SVE) remediation system, and the relocation of three residential drinking water wells. On December 8, 2015, IDEM recommended postponing the installation of new drinking water wells until the remediation system has begun operating and additional ground water sampling data has been collected to evaluate remediation efforts. The remediation system was delivered, installed, and tested the week of June 13, 2016. The system is now fully operational.
