

TITLE 329 SOLID WASTE MANAGEMENT DIVISION

Rule Information Sheet

Transfer Station Reporting
LSA Document #19-424

Overview

This rulemaking amends the reporting requirements of solid waste transfer stations to remove the annual reporting requirement in 329 IAC 11-13.5-17 and move the remaining record keeping requirements to 329 IAC 11-13.5-13. Revisions are also made to 329 IAC 11-13.5-1 for consistency. The transfer station annual report would no longer need to be submitted to IDEM because IDEM staff can view these records during on-site facility visits. Most transfer stations do not submit this specific report and, of those that do, no detection of prohibited waste has been reported. Moving the requirements for the record keeping to 329 IAC 11-13.5-13 makes 329 IAC 11-13.5-17 obsolete, so IDEM is proposing to repeal 329 IAC 11-13.5-17. This rulemaking will update the biosolids and septage acceptance requirements at 329 IAC 11-13.5-13(b)(11) and 329 IAC 11-13.5-13(b)(12) for clarification. In accordance with a statutory change to IC 13-18-12, the term "wastewater" is being replaced with "septage." Transfer stations currently check incoming solid waste including all the items listed in 329 IAC 11-13.5-13(a).

Affected Persons

Solid waste transfer stations will benefit from this rulemaking because it eliminates unnecessary reporting by transfer stations.

Reasons for the Rule

The amendments to 329 IAC 11-13.5-1 and 329 IAC 11-13.5-13 and repeal of 329 IAC 11-13.5-17 will eliminate unnecessary reporting by transfer stations. IDEM can check the facility records during on-site visits.

Economic Impact of the Rule

There will be a positive fiscal impact from the implementation of this rule because it eliminates unnecessary reporting by transfer stations.
