


Metrics on Progress

- 140 facilities with approved 50% reimbursement eligibility have closed tanks
- 88 facilities are no longer regulated (212 Comp/Tanks)
- 392 USTs have been closed.
 - 1 from the 1950s
 - 27 from the 1960s
 - 89 from the 1970s
 - 152 from the 1980s
 - 123 from the 1990s
- 90 facilities have submitted cost claims for 50% reimbursement.

1-12 Compartments Amt Reimbursed










Compartments over 30 yrs

Agency Updates

- Executive Order 25-38
 - Governor Braun issued Executive Order 25 -38, Creating Opportunity through Reduction of Excessive Environmental Regulation, on March 12, 2025
 - In May 2025, IDEM issued a public solicitation for comments and received 1400 pages of public comments
 - IDEM's response included a review of Underground Storage Tank (UST) Notification Forms (Ind. Code 13-23- 1-2(c)(8), 329 IAC 9-2-2)





Agency Updates

- ELTF Rule Status, 328 IAC 1
 - Draft language with Indiana Office of Management and Budget
 - Anticipate comment period to begin in early 2026
 - Draft languages includes:
 - Incorporation of reimbursement for regulated AST releases and UST Decommissioning and Replacement
 - Updated cost guidance
 - · Utilizing eligibility requirements at the time of application submittal
