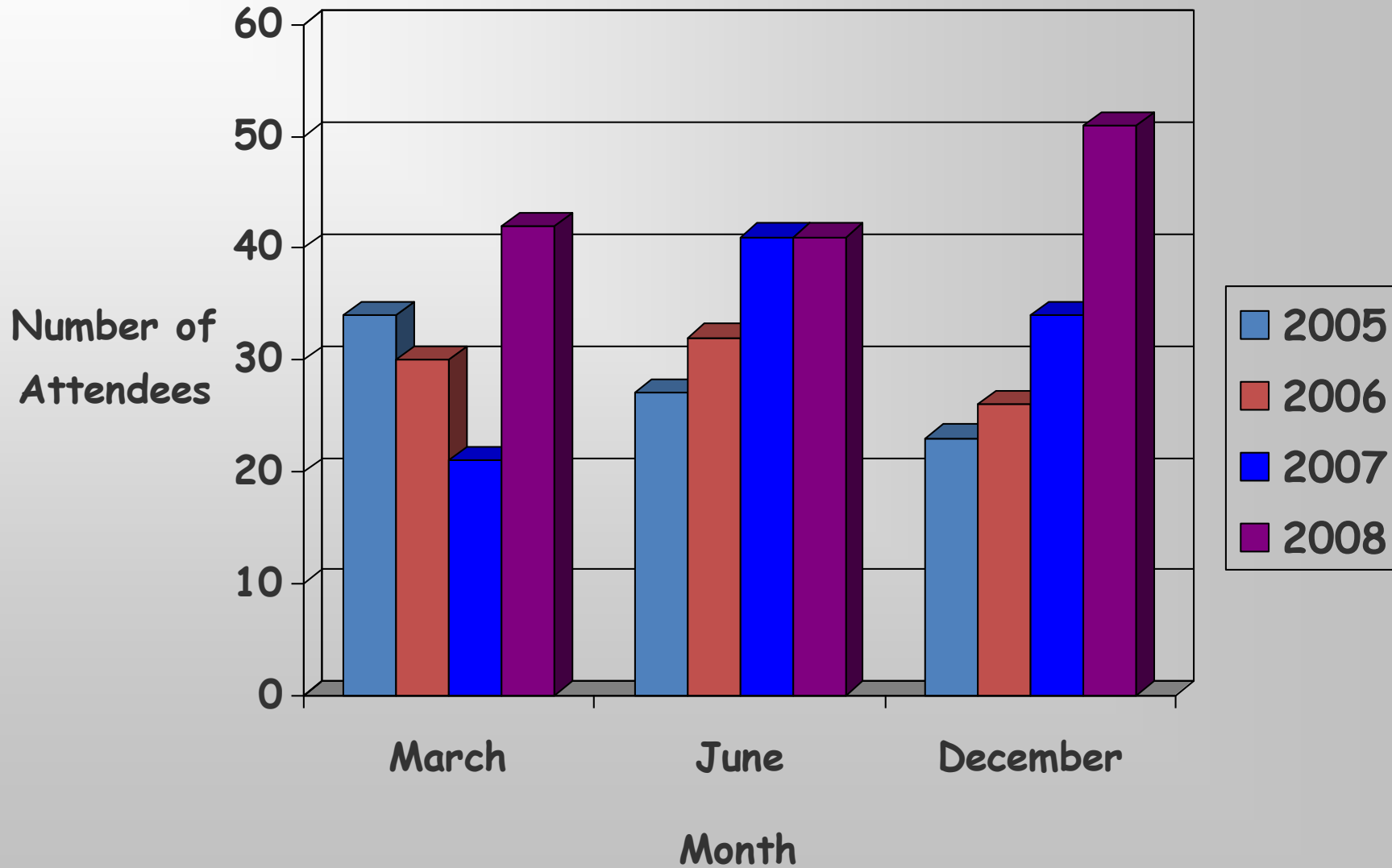


2009 Governor's Awards for Environmental Excellence

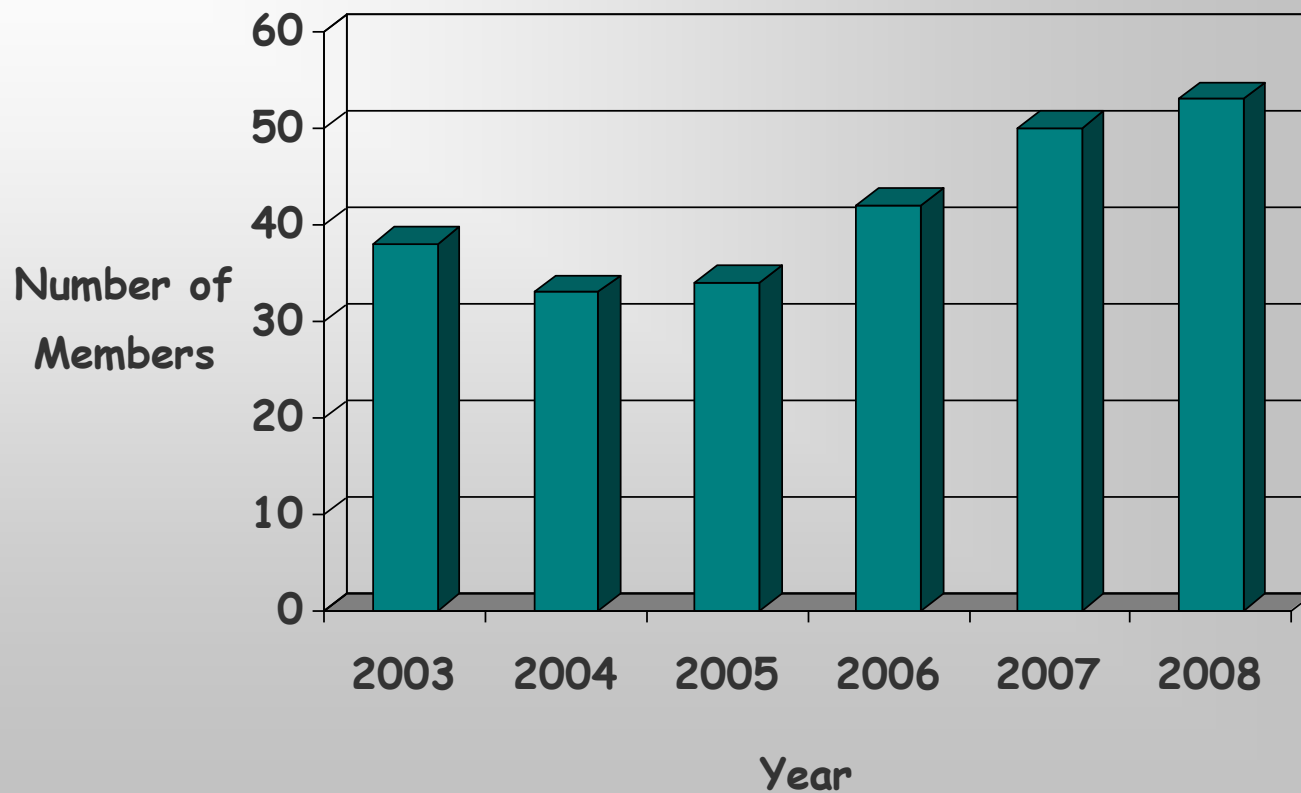

Quarterly Partners Meeting Attendance



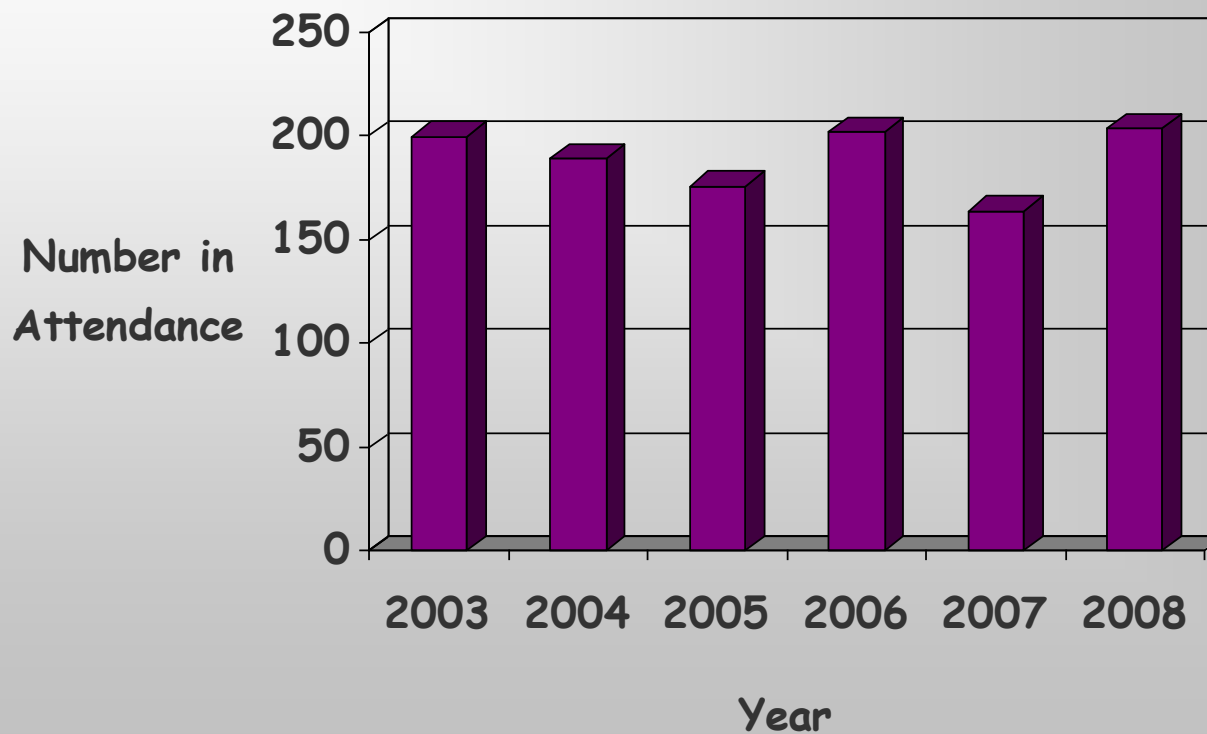

New ESP Member Benefits

- 1. Reduced match requirement for P2 Grant**
- 2. Reduced match requirement for 3 R's Assessment Grant**
- 3. Reduced match requirements for 3 R's Equipment Grant**
- 4. Reduced Self-Inspection Frequency (329 IAC 3.1-1-7 and 329 IAC 3.1-7)**



New 3R's Equipment Grant

- Available to businesses that have completed a waste assessment
- Up to \$40,000 with a 50% match
- As previously noted, there is a reduced match for ESP Members
- Pre-Proposals due January 23rd
