Recycling Market Development Board Members

The Recycling Market Development Program (RMDP) is administered by IDEM and operates under the Recycling Market Development Board as established by [IC 4-23-5.5](#). The Board may promote, fund, and encourage programs facilitating the development and implementation of waste reduction, reuse, and recycling in Indiana. They determine all final funding for eligible projects.

The Board consists of nine voting members, who are appointed by the governor's office, as well as seven non-voting ex officio members. Ex-officio members must consist of:

- Governor (or their representative)
- Director of DNR (or their representative)
- Commissioner of IDEM (or their representative)
- Two members of the House of Representatives (each of opposite party); appointed by the speaker of the house of representatives for two (2) year terms that expire June 30 of each odd-numbered year
- Two members of the Senate (each of opposite party); appointed by the president pro tempore of the senate for two (2) year terms that expire June 30 of each odd-numbered year
