Meeting Minutes

I. Call to Order

Chairman Wilson called the meeting to order Monday, December 11, 2017 at 1:03 p.m.

II. Roll Call

III. Establish quorum

Having 8 voting members, quorum was established for the meeting.

IV. Adoption of Past Minutes

Chairman Wilson entertained a motion to adopt the minutes from the September 11, 2017 meeting.

The motion was unanimously passed and the Governor's Commission on Minority and Women's Business Enterprises meeting minutes were adopted.

V. Update from Chairman Wilson

Chairman Wilson gave an update from the Commissioners Retreat that took place on November 14, 2017.

The recommendation from the retreat was the participation goals to remain the same on all State of Indiana contracts. Those goals are as follows:

- 7% MBE & 5% WBE in Construction
- 4% MBE & 7% WBE in Supplies/Procurement
- 8% MBE & 8% WBE in Professional Services

Chairman Wilson entertained a motion to adopt the participation goal percentages.

The motion was unanimously passed and the Governor's Commission on Minority and Women's Business Enterprises participation percentages were adopted.

VI. Executive Director's Report

Maia Siprashvili-Lee, the Executive Director of Supplier Diversity gave a general overview of 2017:

- Thirty (30) events within and outside of Indianapolis attended
- Revising the INDOT Good Faith Effort process regarding Minority and Women business participation on INDOT Public Works contracts
- Working on the Commission Retreat deliverables
- Hiring new staff members in Business Outreach & Compliance, as well Certification – these individuals will help to reduce the average days to certify and allow us to attend more outreach events

Chairman Wilson added that the Commission meetings will be coupled with outreach events to become more engaged with the community of business owners.

Following the overview, Amy Wolf, Deputy Director of Certification, gave an update on certification statistics:

- 46 New Incoming Applications during the 4th quarter
- 49 Recertification Application during the 4th quarter
- 107 Applications completed during the 4th quarter
- 7 preliminary denials were processed during the 4th quarter and 0 denials were processed
- The average days to in the 4th quarter was 53.54

There was discussion amongst the Commissioners regarding on-site visits during certification process and the possibility to survey business owners about recertification.

Kesha Rich, Deputy Director of Business Development and Compliance, followed with her report detailing the number of "Good Faith Effort Reviews" conducted, and the division's outreach activities:

- 4 INDOT Good Faith Effort Reviews were conducted in the 4th quarter, 0 Public Works Reviews were conducted
- 3 Certification Webinars
- 9th Annual DSD Business Conference
- Attended 7 partner outreach events

Art Sample, Supplier Diversity Vendor Manager, followed with statistics regarding prime vendor's spend with State certified MWVBEs.

There was discussion about if there are repercussions if prime or sub-contractors are non-compliant on contracts and who issues those sanctions.

Commissioners questioned the overall goals and participation percentages as percentages as reported by each SEI.

VIII. INDOT DBE Program Update

Derrick Casson presented the Indiana Department of Transportation DBE program update. He provided an update on certification, contract compliance and support services. He reported certification statistics, including number of certified firms. He also included updates on current and future INDOT projects in relation to their supplier diversity goals.

IX. New Business

Doneshia Posey, Acting Legal Advisor to the Commission, discussed the next steps and roles for the Commission to hear the appeal of denial hearing for Lab Verdict, a MBE that was denied certification.

The Commissioners requested to hold a separate meeting to discuss its roles and responsibilities and the motion was unanimously passed.

Erin Kellam, the Deputy Commissioner provided updates on the restructuring of the Division of Supplier Diversity.
