III. MBE/WBE/IVOSB Vendor Presentations

Three selected vendors pitched their businesses and gave brief presentations to the Governor's Commission on Supplier Diversity that met the following criteria:

- 1. They needed to be certified with the IDOA as an MBE, WBE, or IVOSB.
- 2. They needed to not have had any contracts with either the State of Indiana or the SEIs.
- 3. They would have to be willing to participate on State of SEI contracts.
- 4. They would have to be willing to travel to Indianapolis, IN for an in-person presentation.

Each SEI gave a brief overview of their overall goals and utilization percentages for the **quarter**. The SEIs that presented their reports were:

VI. INDOT DBE Program Update

Elizabeth Kiefner Crawford presented the Indiana Department of Transportation Disadvantaged Business Enterprise (DBE) program update. She provided an update on certification, contract compliance and support services. She reported certification statistics, including number of certified firms. She also included updates on current and future INDOT projects in relation to their supplier diversity goals.

- 2021 Recap
 - o 145 new applications received.
 - There were 640 applications processed (new applications + no changes).
 - Average Processing Time ("APT") = 15.73 Days.
- 2022 Data (through 11/30/22)
 - 94 New Applications Received (Decrease by 35%)
 - 771 Applications Processed (Increase by 17%)
 - o Successfully completed clean up of firms that failed to complete no change information
 - APT Workforce Education Services Updates
 - Average Processing Time ("APT") = 21.24 Days.

(Fed law- 90 days in state, 60 days out of state)

- DBE Supportive Services Update
 - Current Projects
 - DBE 3-year reviews for 72 DBEs.
 - DBE 3 year review survey focused on interest in INDOT work.
 - XBE workshop series launching in 2023 in collaboration with the Muncie. Delaware Chamber of Commerce, IDOA, and the City of Indianapolis.
 - DBE Supportive Services survey scheduled for release in late December.
 - CEI power session webinars have been occurring twice a month.
 - Statewide DBE Forum in collaboration with CEI February 28th.
