i **GENERAL**

In order to help streamline review of the product pricelist, the following is one of the most commonly purchased items:

NOTE: If the software needs to be installed, IOT requests that the Agency submit a ticket to have the product packaged so a desktop technician could deploy it through the software center. If these procedures are not followed it makes it difficult for IOT to support the workstation.

i **ISSUING PURCHASE ORDER (PO)**
 All quote and SoW’s should contain the following language, at a minimum:
 "This quote/PO is based on the State of Indiana Contract Number (QPA) # 18197 and the GSA Contract GS-35F-0256K."
