CONTRACT OVERVIEW

The vendor provides laboratory, medical, and industrial gases (in bulk and high pressure cylinders) for customers needing gas products. Historically, these products have been utilized by Indiana State Police for the forensic laboratories and State Police garages, as well as the Indiana State Department of Health, the various State Hospitals, the Indiana Veterans Home, and some Department of Correction facilities.

The tanks that contain the gases may be rented from the vendor and cannot be purchased from this QPA contract. For rentals, there will be a daily rental fee for each day the tank(s) are at the State location. Should the State agency lose or damage a tank, the agency will also be charged for the replacement cost of the tank. Those prices are specified as line items on the contract.

CONTRACT PRICES

Pricing is specified by gas per cylinder (line items 1-45). Available gases include Acetylene, Argon, Carbon Dioxide, Helium, Hydrogen, Nitrogen, Oxygen, and mixes of these gases. Various cylinder sizes are available as well.

Also included is pricing for daily tank rental of gas containers and liquid containers (line items 46-47).

Pricing for damaged/lost tanks is specified per cylinder (line items 48-65).

All prices include FOB Destination shipping.
