Estimated Amount of two (2) year contract: \$1,055,127.54

Based on the State's evaluation of responses received for negotiated Bid 515-23-75269, Brown & Pratt, Inc. is recommended for award in all categories to provide corrugated boxes. Terms of the award recommendation are outlined in this letter.

Type of Award

The State intends to establish a contract for a period of two (2) years. The contract can be mutually renewed yearly for two additional years under the same terms and conditions.

Renewals are subject to the approval of the Department of Administration and the State Budget Agency. Total term of this agreement including all renewals, shall not exceed four years.
