Re: Letter of Intent between Aramark Correctional Services, LLC and Cristina Foods, Inc. Regarding RFP No. 23-74802 issued by the Indiana Department of Correction Juvenile Services.

Dear Mr. Dovalina:

This letter of intent ("Letter of Intent") will confirm the understanding between Cristina Foods, Inc. ("Vendor"), and Aramark Correctional Services, LLC ("Aramark," together with Vendor, the "Parties"), regarding (i) the proposal (the "Proposal") to be submitted by Aramark to the Indiana Department of Correction (the "Client") in response to the Client's Request For Proposal # 23-74802 (the "RFP") for juvenile correctional facilities food services on the Client's premises; and (ii) the Parties' intention to enter into a Vendor Agreement for certain food products (the "Vendor Agreement") between Aramark and Vendor upon the award by the Client of a contract to Aramark in response to the Proposal (the "Contract").

The Parties hereby agree to the following terms:

1. **Relationship of the Parties.** Vendor acknowledges that Aramark intends to submit a Proposal to Client in response to the RFP. Vendor grants to Aramark the right to include materials provided to Aramark by Vendor as part of the Proposal, and also the right to make reference to the name, logo, materials, products and/or services of Vendor in the Proposal. The Proposal will indicate the Parties' good faith intent to enter into a Vendor Agreement in the event the Contract is awarded to Aramark. Vendor has reviewed the RFP and hereby certifies its ability to comply with all terms, conditions, specification, and requirements contained therein that may be applicable to any subcontractors of the successful bidder.


2. **Minority Certification:** Vendor represents and warrants that it is currently registered and certified as a Minority-owned Business Enterprise ("MBE") as those terms are defined in the RFP, by a certifying agency that meet the requirements set forth in the RFP (if any). Vendor further represents and warrants that at all times during the term of this Letter of Intent Agreement and any resultant Vendor Agreement will maintain its certification with such certifying agency. Vendor shall immediately notify Aramark in the event of any change in its certification.

3. **Agreement.** In the event the Contract is awarded to Aramark, Vendor and Aramark will negotiate in good faith the terms of a Vendor Agreement. The Vendor Agreement will govern the Parties' relative rights and responsibilities with respect to the Contract.

Please indicate your agreement with the above terms and conditions by signing a copy of this Letter of Intent and returning the same to Aramark.


