We are registered with The Secretary of the State of Indiana as a Corporation dated 27 February 1956. Our Business ID # is 194214-042

Diversity Subcontractor Agreements: we will not be partnering with MBE, WBE or IVOSB subcontractors on this bid because due to its nature, there are no XBE subcontractor company opportunities associated with this bid.


