Dear Sir or Madam:

By our determination letter dated December 27, 1957, you were held to be exempt from Federal income tax under the provisions of section 501(c)(3) of the Internal Revenue Code. Subsequently, we determined that you were not a private foundation because you were described in sections 509(a)(1) and 170(b)(1)(A)(iii).

You recently submitted information resulting in the following:

1. You, formerly The Lutheran Hospital of Indiana, Inc., merged with The Lutheran Health Foundation of Indiana, Inc. (35-6070473), from which you are the survivor. The effective date of the merger is July 31, 1995.

The merger does not affect your exempt status under section 501(c)(3) of the Code.

The status of the non-survivor (35-6070473) is the subject of a separate letter.

2. Your organization, the survivor, no longer operates as a hospital.
3. Based on the same facts as presented in the private ruling request and subsequent correspondence and those on which our National Office relied before issuing the 7/25/95 Private Ruling Letter, we have reclassified your organization as one that is not a private foundation as defined in section 509(a) of the Code because you are an organization described in section 509(a)(3). Your foundation status under section 509(a)(3) is effective July 31, 1995, the date of the merger.


