It is important that your agency includes a copy of this Medicaid Waiver Service Provider Certification and the Certification of Provider Enrollment, when you submit your enrollment package to HP. This will allow the reviewer in that office to assess your request accurately and to assist you through this enrollment process.

Once you have successfully completed the Medicaid Provider Enrollment Application, the HP office will notify our office and your agency directly.

Please understand that until you receive the final certification notice from HP, billing for services is not authorized. All billing issues and address changes need to be addressed through HP.

If you also applied to provide State Contracted services, BDDS will forward this certification and the necessary documentation to the Division of Disability and Rehabilitative Services (DDRS) Contract Specialist. Please understand that until your agency receives the signed contract from the Division of Contract Management, your agency should not provide services through Stateline funding.


