To Whom it May Concern,

Four County Comprehensive Mental Health Center (DBA 4C Health) is a certified Community Mental Health Center and Private Mental Health Institution by the Indiana Division of Mental Health and Addictions. We are a registered entity with the Secretary of State and in good standing. We maintain a continuum of behavioral health and substance use care, including 24/7/365 crisis services, as required by Indiana Statute. We are also a Joint Commission accredited behavioral healthcare agency. 4C Health has been in business for over 45 years in North Central Indiana. We started out as the designated Community Mental Health Center for Cass, Miami, Pulaski, and Fulton counties. In 2015 expanded to Howard County, 2016 Tipton county, 2017 to White County, and since then have expanded to service to an additional nine North Central Indiana counties. We specialize in rural behavioral healthcare.

In 2020, we sought to expand the crisis care continuum in our rural area by adding a 4-chair Crisis Stabilization Unit for adults and Mobile Crisis Team services to Cass, Miami, Fulton, and Pulaski counties. We have successfully managed and ran rural Mobile Crisis Teams for a little over 3 years now. Mobile Crisis Teams now services 7 total counties. We are presently completing construction to expand our Inpatient Psychiatric Unit to service adolescents and we are constructing a Youth Crisis Stabilization Unit. We are currently a State DMHA Primary Care Behavioral Health Initiative grantee to expand whole health initiatives within the CMHC population. This grant sets the stage well for achieving the CCBHC primary care screening and wellness requirements. Further, we are currently in process of starting primary care services by end of 2023. We participated in the State's CMHC Deep Dive and CCBHC readiness assessment. We have initiated and completed plans on our own to address areas the readiness assessment pointed to needed improvement/investment. Finally, our electronic health record already has a CCBHC module that can be purchased and implemented early in the demonstration period with little customization needed to be operational.

We are well positioned to supply the Certified Community Behavioral Health Services (CCBHC) services being procured by the State of Indiana and to certify. We desire to be selected to be part of the CCBHC RFS. Finally, we confirm that we meet the mandatory requirements in the RFS to participate in the CCBHC RFS.


