[Sublocade](#) injection, for subcutaneous use, is a prescription medicine used to treat adults with moderate to severe addiction (dependence) to opioid drugs (prescription or illegal). Must be administered by a certified healthcare provider.

Braeburn (Brixadi)

Henry Schein has an exclusive Contract with MMCAP Infuse and Braeburn, with specialty contract pricing for Brixadi, on our Medical Supplies and Equipment Contract with MMCAP.

BRIXADI (buprenorphine extended-release) injection, for subcutaneous use (CIII) is indicated for the treatment of moderate to severe opioid use disorder in patients who have initiated treatment with a single dose of a transmucosal buprenorphine product OR are already being treated with buprenorphine.

- BRIXADI should only be prepared and administered by a healthcare provider.
- BRIXADI exists in two formulations: **weekly and monthly**
- BRIXADI is administered by subcutaneous injection in the buttock, thigh, abdomen, or upper arm.

There is a 10% discount for all Agencies, on all Brixadi item skus. To get access to the contract pricing, an 'Required Member Onboarding Form' must be completed by the customer and submitted to mmcap_infuse.contracts@state.mn.us.

SUBLOCADE and BRIXADI are CIII controlled substances. Customers purchasing SUBLOCADE and/or BRIXADI, whether Healthcare settings or Pharmacies, must meet the below criteria:

1. Must be certified in the SUBLOCADE REMS program by Indivior and/or BRIXADI REMS program by Braeburn
2. Must have a valid DEA registration for controlled substances.
3. Must comply with the Henry Schein “know your customer” due diligence process prior to purchase. It is likely that the first order will pend for this to be completed.

If the account should be coded tax exempt, please provide a Tax Exemption Certificate to your Henry Schein Representative.

Ordering

Most MMCAP accounts must order through their own system, whether this be a state-wide system or an account specific punch-out system.

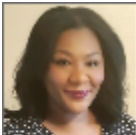
