This is an Amendment/Renewal to the Contract entered into by and between the Indiana Department of Administration (hereinafter referred to as "State") and the Goodyear Tire & Rubber Company (hereinafter referred to as "Contractor") dated 4/1/2011. In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree to amend the existing contract as follows:

Market Basket

The parties agree to amend the Market Basket as outlined below. This change reflects the discontinued production of P215/60R16, PC 738276571 and the substitution of 215/60R16, PC 738571571. The new tire is a comparable tire and is the same discounted percentage off list price.

To Delete

- Item # 100014274, P215/60R16, PC 738276571, \$64.83

To Add

- 215/60R16, PC 738571571, \$68.74

All other matters previously agreed to and set forth in the original agreement and not affected by this Amendment shall remain in full force and effect.
