## INTRODUCTION

The new Indiana Juvenile Detention Standards are in the process of being adopted, therefore the 20<sup>th</sup> annual evaluation of the Allen County Juvenile Center consisted of an audit of the current 26 mandatory compliance standards or the corresponding 16 newly proposed mandatory compliance standards. Compliance with 100% of the mandatory standards is required to attain "Full Compliance".

<b>Detention facility's mission</b>	The Allen County Juvenile Center views the concept of

detention as being able to provide the community a continuum of services directed toward meeting the needs of individual juveniles who, for the protection of the community or themselves, must temporarily be removed from their homes. The need for security measures within the detention program of the Allen County Juvenile Center is recognized and can be implemented to the degree necessary to provide the controls needed for the care, protection, and treatment of each juvenile. Although the juvenile is being detained, even for a short period of time, the Allen County Juvenile Center believes that each juvenile should be treated with respect and provided opportunities to act in a responsible self-enhancing manner. This is accomplished through a varied and active program of education, recreation, counseling, aggression management, and social competence programming. Allen County Juvenile Center believes that this is the most productive atmosphere in terms of the juvenile being prepared for the return home or to a future placement facility. In implementing this philosophy, the Allen County Juvenile Center relies primarily upon the ability of all staff members at the facility to establish constructive relationships with the juveniles that are detained. Through the programming we offer and the relationship that we help them to experience, some degree of trust, responsibility, and meaningful activity is produced. This requires, on the part of the staff members, a high degree of sensitivity, respect, trust, and ability to demonstrate concern for, and to communicate with children who are hostile, alienated, and either unwilling or unable to engage in constructive relationships with adults. The Allen County Juvenile Center and its employees are dedicated to serving the needs of the Allen County community and its residents. # SUBSEQUENT ANNOUNCED AND/OR UNANNOUNCED VISIT(S)

On 1/20/2016, a subsequent visit was conducted of the Allen County Juvenile Center by Chance Sweat. The facility tour was conducted by Director Armstrong. When I arrived the youth were participating in education. The facility population count is 46 youth. All areas appeared to be well-maintained and sanitation levels in the facility were found to be satisfactory.

On 2/24/16, a second subsequent visit was conducted of the Allen County Juvenile Center by Chance Sweat. The facility tour was conducted by Director Armstrong. Youth were observed participating in education and eating lunch. The facility population count was 58. All areas appeared to be well-maintained, and the sanitation level was satisfactory.

On 7/20/2016, a third subsequent visit was conducted of the Allen County Juvenile Center by Chance Sweat. The facility tour was conducted by Director Armstrong. When I arrived the youth were participating in education. The facility population count is 36 youth. All areas appeared to be well-maintained and sanitation levels in the facility were found to be satisfactory.

# **TECHNICAL ASSISTANCE VISIT(S)**

The Allen County Juvenile Center's education technical assistance visit occurred on 1/20/16 and was conducted by Kristin Herrmann. The education program follows the local school corporation's calendar and provides special programming during extended breaks. An instructional day is six hours. Instruction is delivered via an on-site, licensed classroom teacher either utilizing a curriculum created at the facility, overseeing an approved online instructional program or facilitating work assigned from the juvenile's home school. The method of instruction depends on the juvenile's need. Program staff includes six full-time teachers, four part-time teachers, one full-time transition coordinator, and one full-time administrative assistant.

The Allen County Juvenile Center's training and development technical assistance visit occurred on 3/16/16 and was conducted by Chance Sweat and Kristin Herrmann. The technical assistance provided included identifying key changes to the standards, answering questions, and discussing the facility's training plan.

#### CONCLUSION

Allen County Juvenile Center is in full compliance with the 2016 Indiana Detention Center Standards Audit performed by the Indiana Department of Correction, Division of Youth Services.
