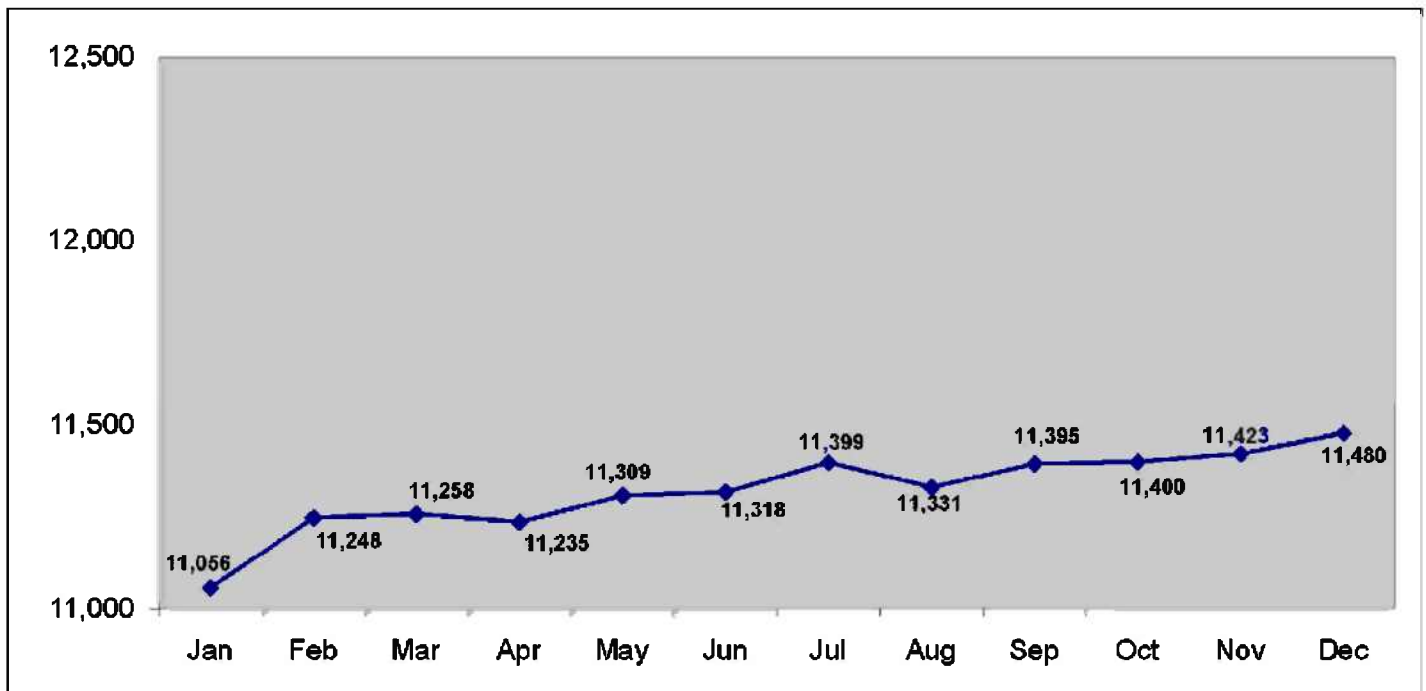

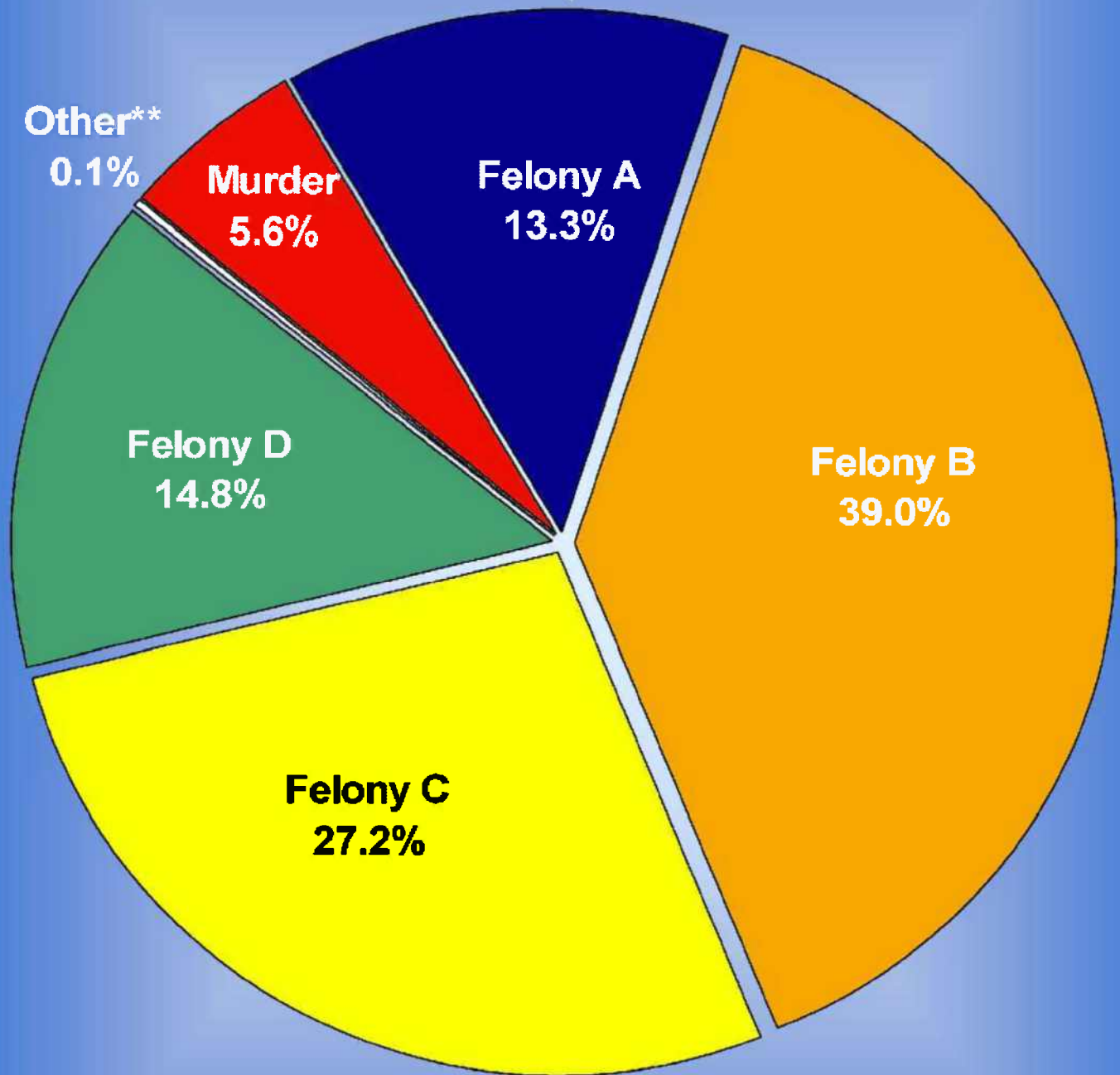

Average Daily Adult Female Offender Populations Calendar Year 2010

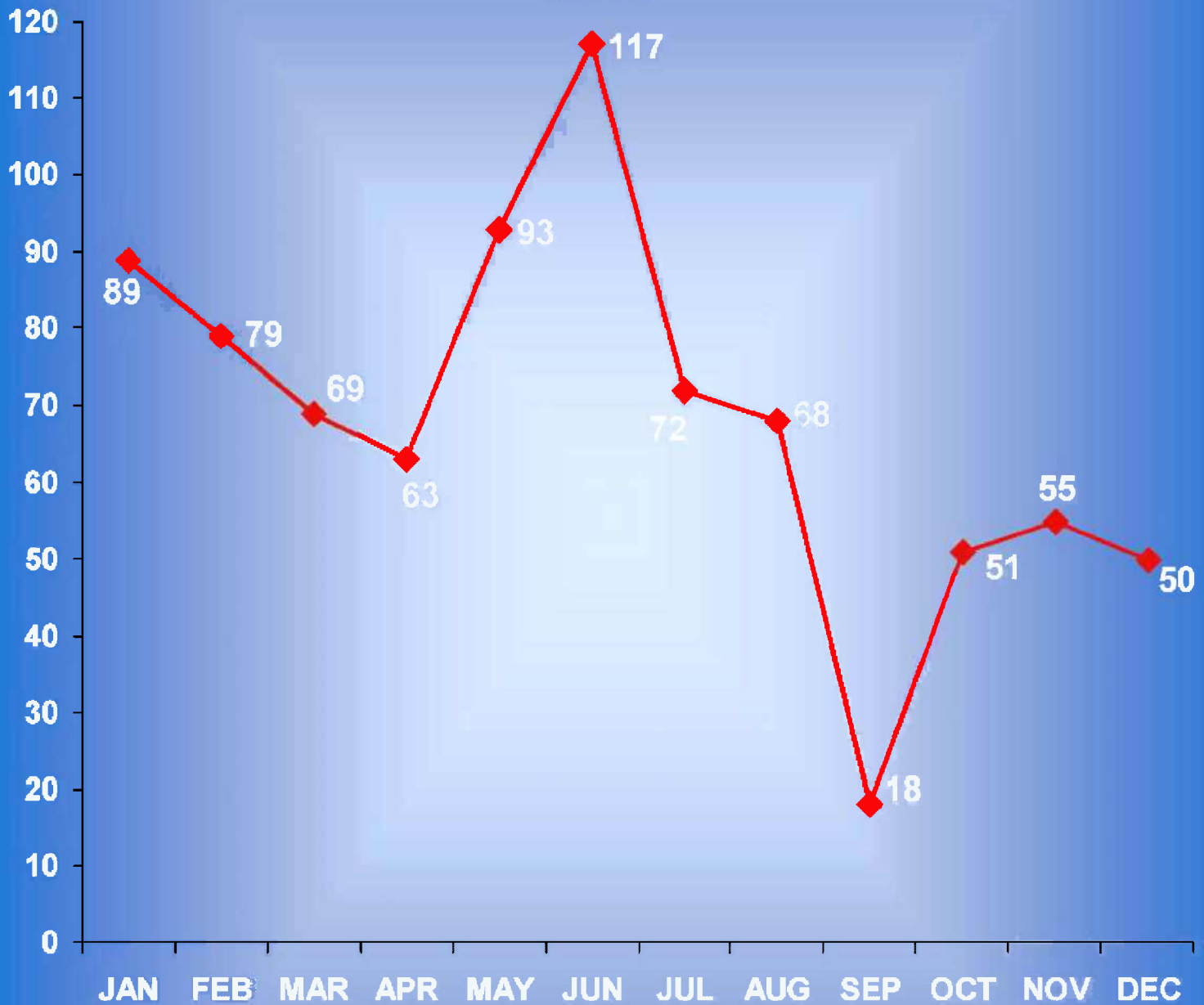

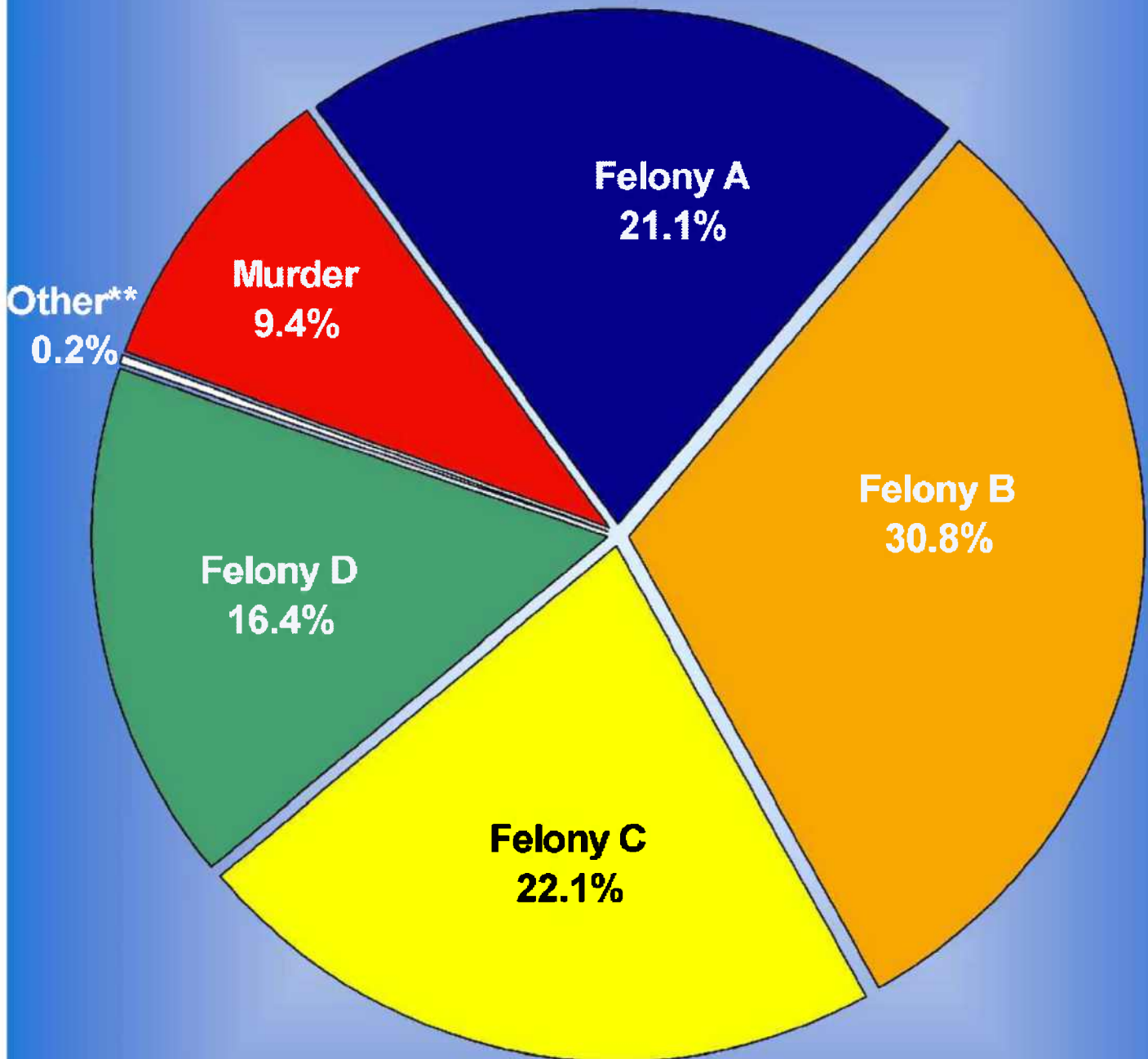

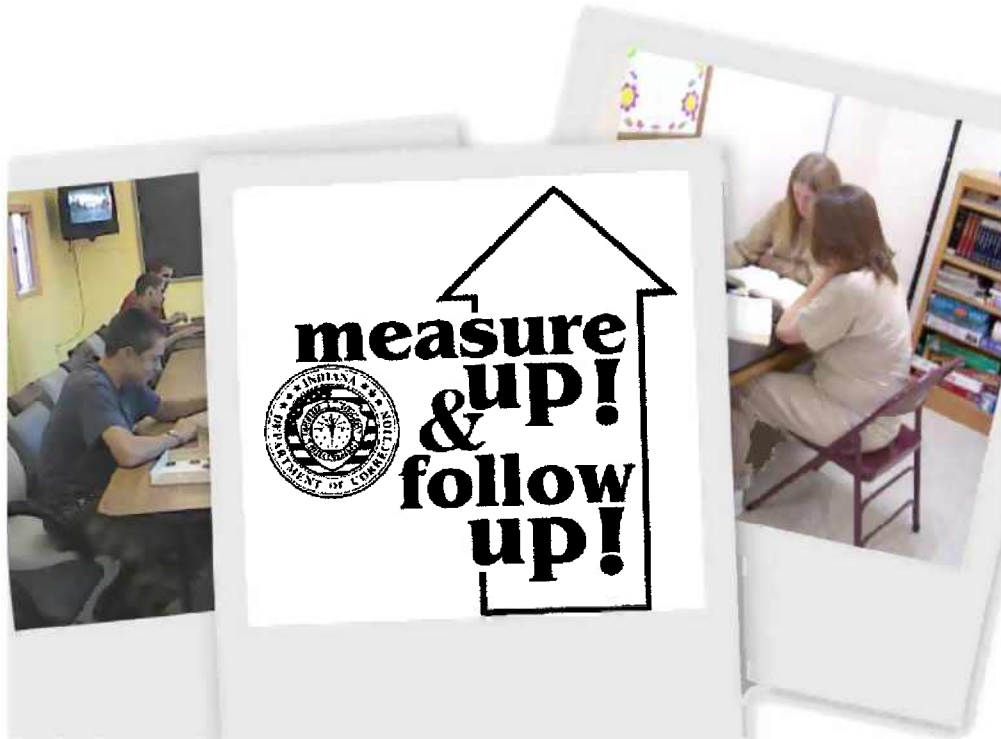
