INTRODUCTION Howard County- Robert J. Kinsey Youth Center

The new Indiana Juvenile Detention Standards are in the process of being adopted, therefore the 20th annual evaluation of the Howard County- Robert J. Kinsey Youth Center consisted of an audit of the current 26 mandatory compliance standards or the corresponding 16 newly proposed mandatory compliance standards. Compliance with 100% of the mandatory standards is required to attain "Full Compliance".

SUBSEQUENT ANNOUNCED AND/OR UNANNOUNCED VISIT(S)

On 1/29/2016, a subsequent visit was conducted of the Howard County- Robert J. Kinsey Youth Center Juvenile Center by Chance Sweat. The facility tour was conducted by Mrs. Derrick. Youth were observed participating in education, and the facility population count was 21. The youth appeared to be in good health. All areas of the facility appeared to be well-maintained, and the sanitation level was satisfactory.

On 6/27/2016, a second subsequent visit was conducted of the Howard County- Robert J. Kinsey Center by Chance Sweat. The facility tour was conducted by Mrs. Derrick and (Food Service Supervisor) Ms. Allen. The facility has recently purchased a new stove and food warmer. All youth appeared to be in good health and all areas appeared to be well-maintained and sanitation levels in the facility were found to be satisfactory. Youth were observed participating in education, and the facility population count was 20 youth. Youth and staff at the facility have built 2 raised gardens and produced fresh fruit and vegetables.

TECHNICAL ASSISTANCE VISIT(S)

The Howard County- Robert J. Kinsey Youth Center's education technical assistance visit occurred on 1/29/16 and was conducted by Chance Sweat and Kristin Herrmann. The education program follows the local school corporation's calendar and provides special programming during extended breaks. An instructional day is five and a half hours for up to fifteen students. Instruction is delivered via an on-site, licensed classroom teacher either overseeing an approved online instructional program or facilitating work assigned from the juvenile's home school. The method of instruction depends on the juvenile's need. Program staff includes one full-time teacher.

The Howard County- Robert J. Kinsey Youth Center's training and development technical assistance visit occurred on 3/22/16 and was conducted by Chance Sweat and Kristin Herrmann. The technical assistance provided included identifying key changes to the standards, answering questions, and discussing the facility's training plan.

CONCLUSION

Howard County- Robert J. Kinsey Youth Center is in full compliance with the 2016 Indiana Detention Center Standards Audit performed by the Indiana Department of Correction, Division of Youth Services.
