#### INTRODUCTION

The 2020 annual juvenile detention facility evaluations conducted by the IDOC, Division of Youth Services would normally consist of three on-site facility inspections; staff and youth interviews; and an audit of the state detention standards. Due to the covid-19 global pandemic, we conducted one on-site facility inspection, along with staff and youth interviews, an audit of the state detention standards, and conducted testing on the candlelight levels and ventilation in accordance to the standards requirement.

While the proposed Indiana Juvenile Detention Facility Standards are in the process of being promulgated, Detention Facilities had the option to be audited on three hundred one (301) current detention standards or the corresponding two hundred and thirty-seven (237) proposed juvenile detention facility standards.

LaPorte County Juvenile Services Center chose to be audited on the two hundred and thirty-seven (237) proposed juvenile detention facility standards in 2020, for their 24th annual detention inspection. Of the two hundred and thirty-seven (237) standards audited, sixteen (16) standards require mandatory compliance and the remaining two hundred and twenty-one (221) are recommended standards. Compliance with 100% of the mandatory standards and 90% of the recommended standards is required to attain "Full Compliance." Again, Centers that chose to be audited on the proposed detention standards were only required to meet the expectation of the current detention standards. LaPorte County Juvenile Services Center chose to also provide documentation on the extra standards with exclusively new requirements. The breakdown of each audit listed below is only reflective of the current standards.

Facility Tour:	The facility tour was conducted by Dennis Orr. This inspection focused	
	on mandatory standards. Areas such as medical, janitorial closet,	
	kitchen, visitation rooms, search areas, private interview rooms, youth	
	rooms, youth living areas, personal and property areas, mechanical and	
	safety areas were inspected. It was ensured that staff had access to the Emergency Manual.	
Youth Interviews:	Two youths were interviewed, one male and one female.	
Youth Responses:	Both youths interviewed said that they had never felt unsafe and that	
Touth Responses.	their environment was in good working condition. One did complain	
	about the rooms being cold and the temperature seeming to constantly	
	change. Both said that they had gone through a fire drill and that they	
	were counted and taken to a different part of the building. Both youths	
	suggested better reading material and to have more paper and things to	
	do in their room.	

Staff Interviews:	Two line staff were interviewed, with one having control experience.
Staff Responses:	Both staff went through the process of an emergency evacuation. Youth will be released from rooms by controls (with a key as back-up) and they will be escorted out and count will be conducted. With disabled or high-risk youth they will be assigned two staff. They then described the information found in the permanent log on the housing units to have the count, inventory, movement, health, Covid-19 information, and shift changes. Both staff then said that mechanical restraints are available, but mist have approval from counselors and supervisor. Both staff said their received medical and mental health training upon employment and further training annually. Lastly, they handle youth detoxification by receiving specific instructions from medical and will be given extra food.

Youth Responses:	Both youths said the food was okay and that they did received three, regularly scheduled meals with two of them being hot. They said they received all necessary items during intake and received clean clothing every day and clean bedding once a week on Saturday. Neither had any concerns about medical and felt that they were cared for and their medical and mental health was kept confidential.
