The new Indiana Juvenile Detention Standards are in the process of being adopted, therefore the 20th annual evaluation of the Marion County Juvenile Detention Center consisted of an audit of the current 26 mandatory compliance standards or the corresponding 16 newly proposed mandatory compliance standards. Compliance with 100% of the mandatory standards is required to attain "Full Compliance".

SUBSEQUENT ANNOUNCED AND/OR UNANNOUNCED VISIT(S)

On 2/4/2016, a subsequent visit was conducted of the Marion County Juvenile Center by Chance

Sweat. The facility tour was conducted by Supt Doyle and Asst. Supt. Snider. Youth were observed participating in education and recreation classes under direct supervision of detention staff. The facility population count was 78. All youth appeared to be in good health. All areas of the facility appeared to be well-maintained, and the sanitation level in the facility was satisfactory.

On 4/4/2016, a second subsequent visit was conducted of the Marion County Juvenile Center by Chance Sweat. The facility tour was conducted by Asst. Supt. Snider. Youth were observed participating in education and recreation classes under direct supervision of detention staff. The facility population count was 86. All youth appeared to be in good health. All areas of the facility appeared to be well-maintained, and the sanitation level in the facility was above average.

On 7/19/2016, a third subsequent visit was conducted of the Marion County Juvenile Center by Chance Sweat. The facility tour was conducted by Asst. Supt. Snider and youth were observed participating in education and recreation classes under direct supervision of detention staff and the facility population count is 92 youth. All youth appeared to be in good health and all areas appeared to be well-maintained and sanitation levels in the facility were found to be above average.

TECHNICAL ASSISTANCE VISIT(S)

The Marion County Juvenile Detention Center's education technical assistance visit occurred on 2/4/16 and was conducted by Laurie Elliott. The education program is an approved charter school, following the local public school calendar. An instructional day is six hours. Instruction is delivered via an on-site, licensed classroom teacher utilizing a curriculum created at the facility and overseeing an approved online instructional program. The method of instruction depends on the juvenile's need. Program staff is provided through the charter.

The Marion County Juvenile Detention Center's training and development technical assistance visit occurred on 5/27/16 and was conducted by Kristin Herrmann. The technical assistance provided included identifying key changes to the standards, answering questions, and discussing the facility's training plan.

CONCLUSION

Marion County Juvenile Detention Center is in full compliance with the 2016 Indiana Detention Center Standards Audit performed by the Indiana Department of Correction, Division of Youth Services.
