The new Indiana Juvenile Detention Standards are in the process of being adopted, therefore the 20th annual evaluation of the Porter County Juvenile Detention Center consisted of an audit of the current 26 mandatory compliance standards or the corresponding 16 newly proposed mandatory compliance standards. Compliance with 100% of the mandatory standards is required to attain "Full Compliance".

Facility Tour	 The Center appeared clean, and the residents' furniture was functional and in good condition. The following maintenance issues needed to be addressed: Sleeping rooms and day room areas were in need of fresh paint. Shower areas were in need of fresh paint and/or waterproof covering.
Youth Interviews	 Three youth (two male and one female) were interviewed about their experiences at the Center. Youth reported, without hesitation, feeling safe at the facility. Youth did not make complaints or provide recommendations.
Recommendations	Provide user-friendly software for auditors to review electronic standard folders.

SUBSEQUENT ANNOUNCED AND/OR UNANNOUNCED VISIT(S)

On 2/29/2016, a subsequent visit was conducted of the Porter County Juvenile Detention Center by Chance Sweat. The facility tour was conducted by Assistant Director Lutz. Youth were observed participating in education classes. The facility population count was 18 youth. All youth appeared to be in good health. All areas of the facility appeared to be well maintained, and sanitation was found to be satisfactory. The food service and medical departments were well maintained and organized.

On 8/31/2016, a second subsequent visit was conducted of the Porter County Juvenile Center by Chance Sweat. The facility tour was conducted by Director Cox, and youth were observed participating in education classes and several other youth at court. The facility population count was 12 youth. All youth appeared to be in good health. All areas of the facility appeared to be well maintained, and sanitation was found to be satisfactory. The food service and medical departments were well maintained and organized. During the tour, Mrs. Cox advised the Porter County maintenance staff had recently replaced the HVAC system.

TECHNICAL ASSISTANCE VISIT(S)

The Porter County Juvenile Detention Center's education technical assistance visit was conducted on 1/25/16 by Laurie Elliott. The education program operates year round with instructional days of five hours. Instruction is delivered via an on-site, licensed classroom teacher either utilizing a curriculum created at the facility, overseeing an approved online instructional program, or facilitating work assigned from the juvenile's home school. The method of instruction depends on the juvenile's need. Program staff includes one full-time teacher, one part-time teacher, and one part-time aide.

The Porter County Juvenile Detention Center's training and development technical assistance visit occurred on 5/16/16 and was conducted by Chance Sweat and Kristin Herrmann. The technical assistance provided included identifying key changes to the standards, answering questions, and discussing the facility's training plan.

CONCLUSION

Porter County Juvenile Detention Center is in full compliance with the 2016 Indiana Detention Center Standards Audit performed by the Indiana Department of Correction, Division of Youth Services.
