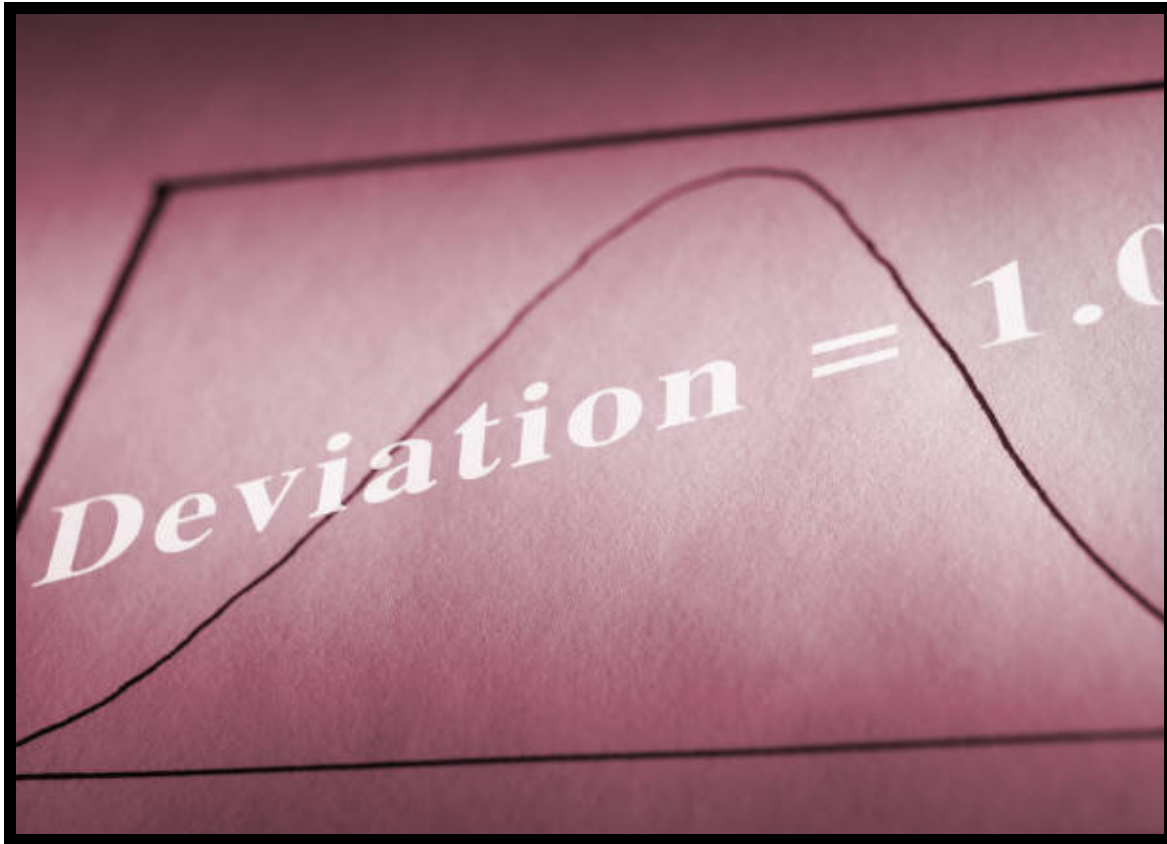

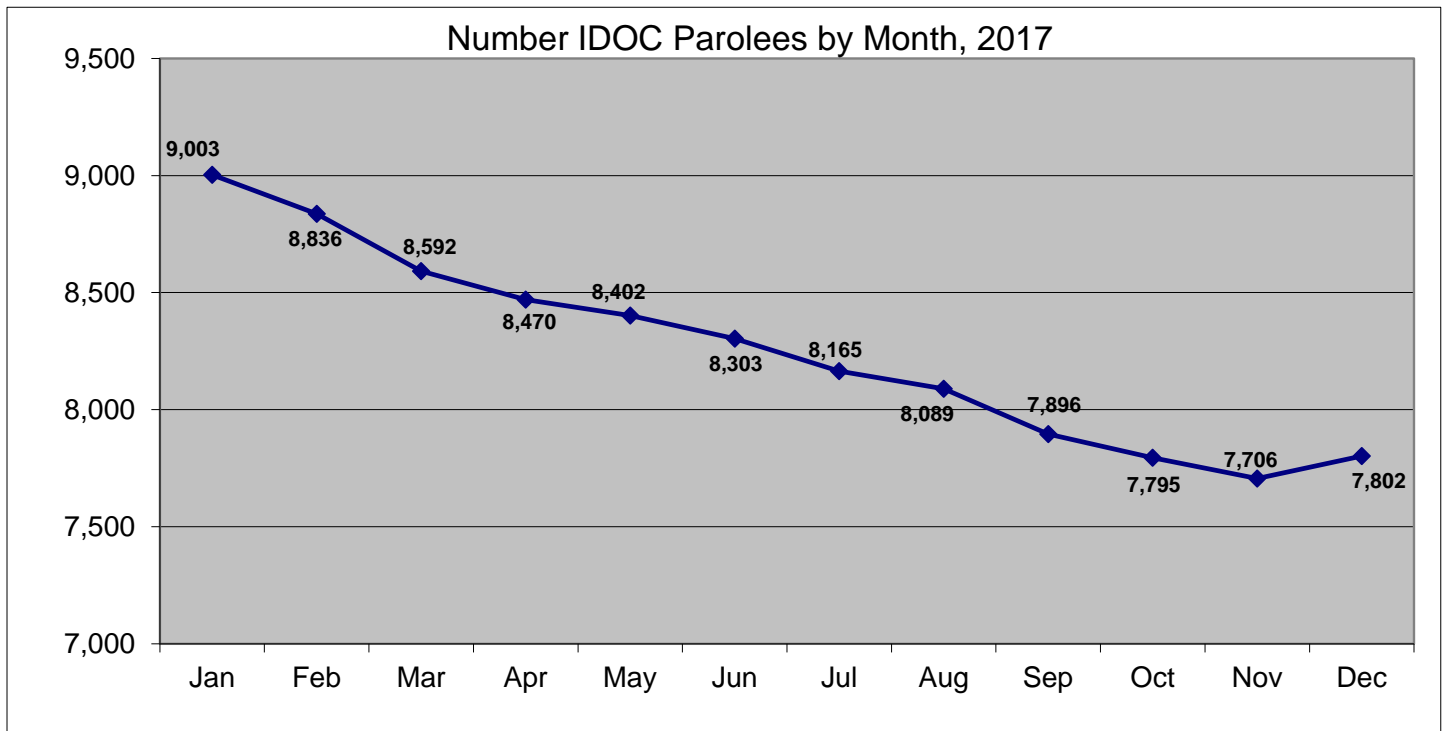

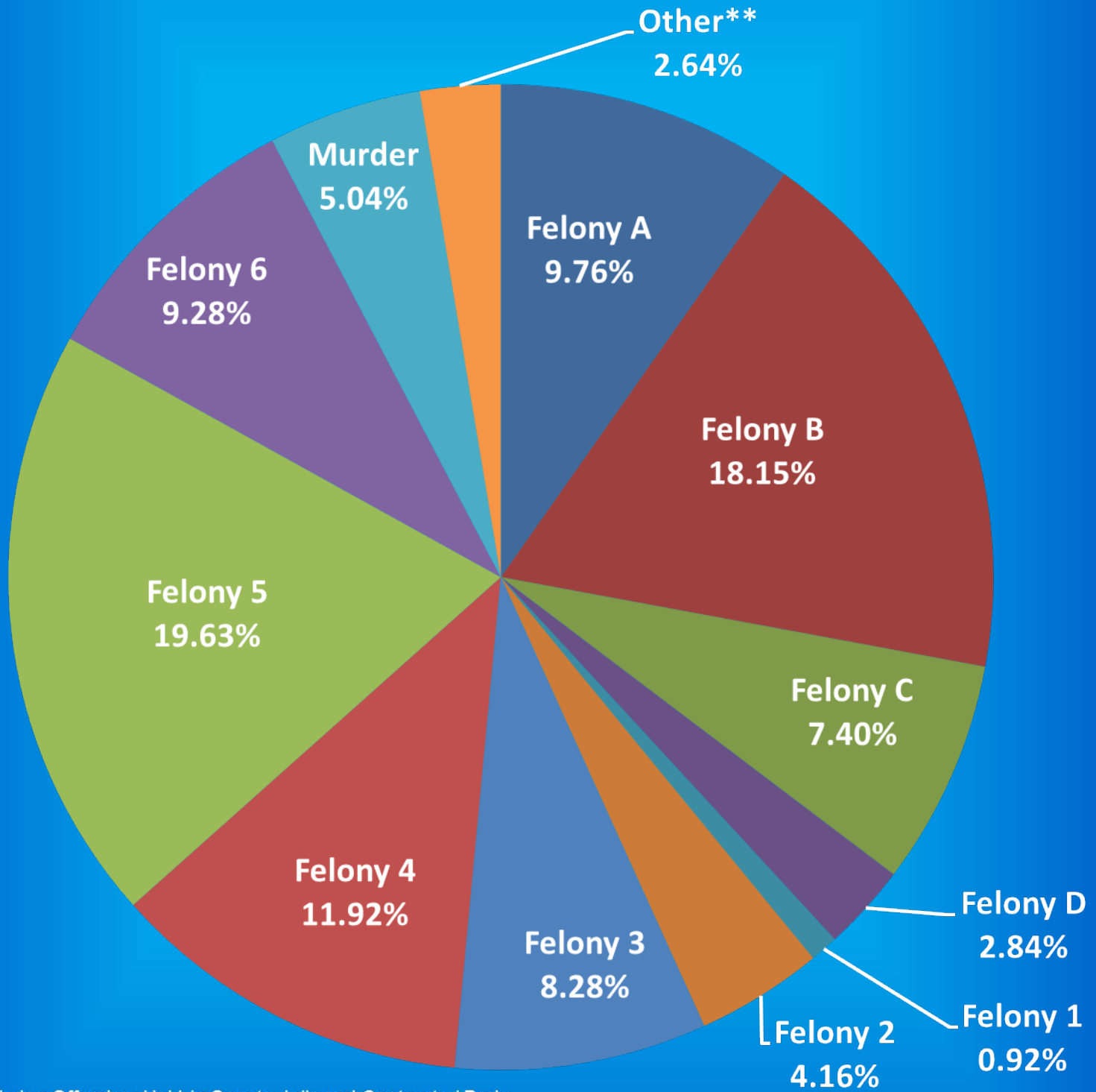

### Average Daily Adult Female Offender Populations Calendar Year 2017

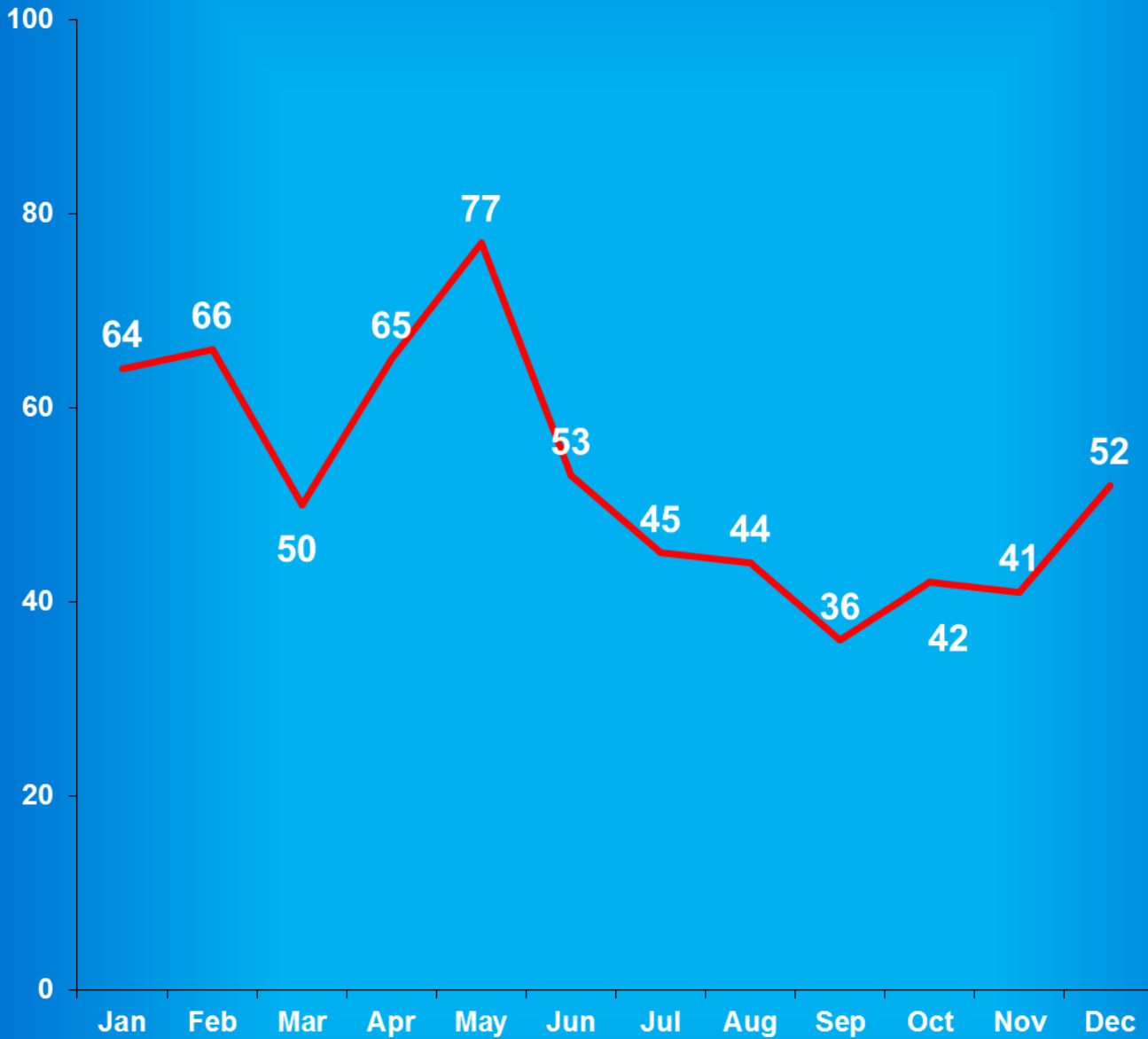

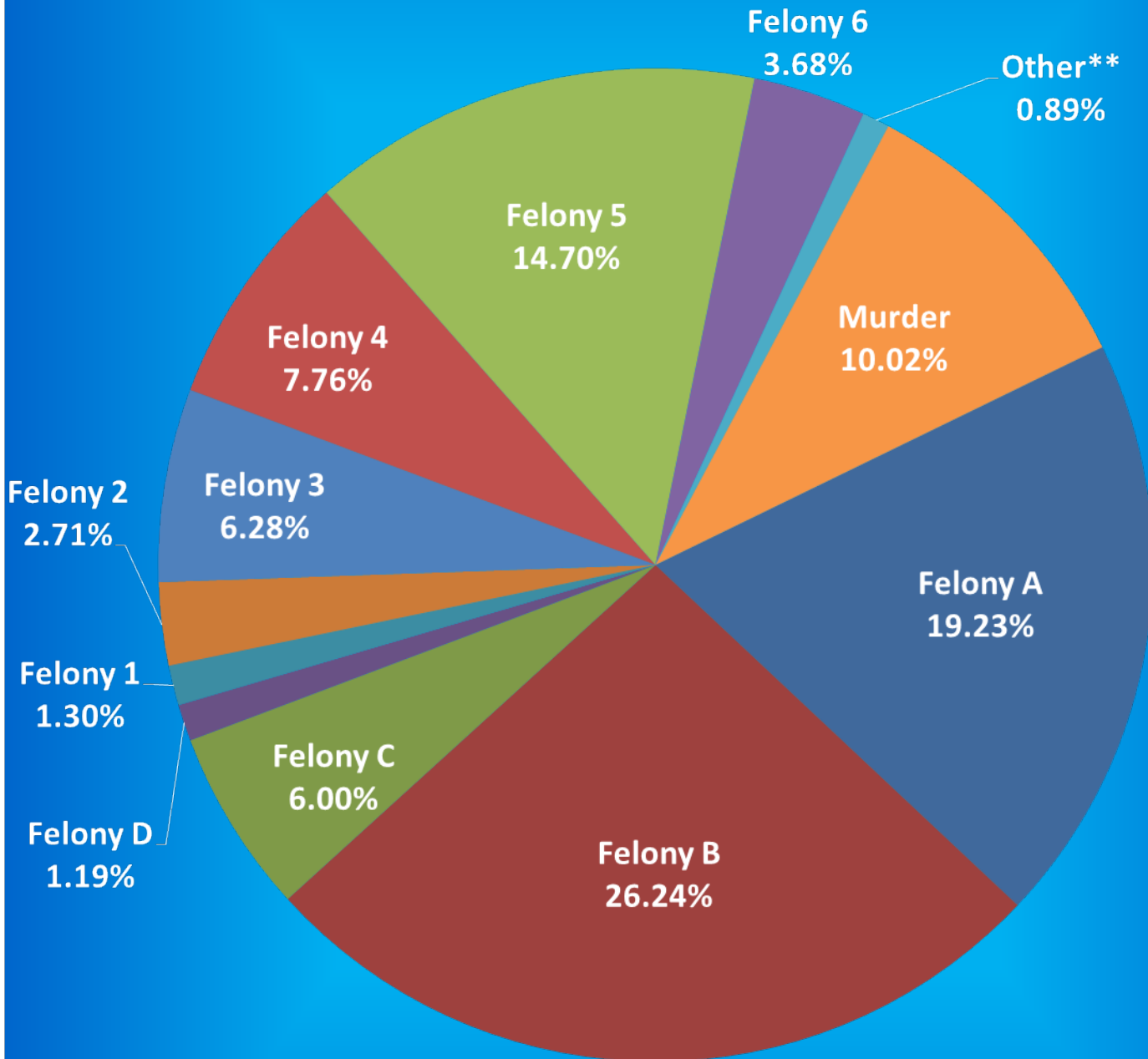

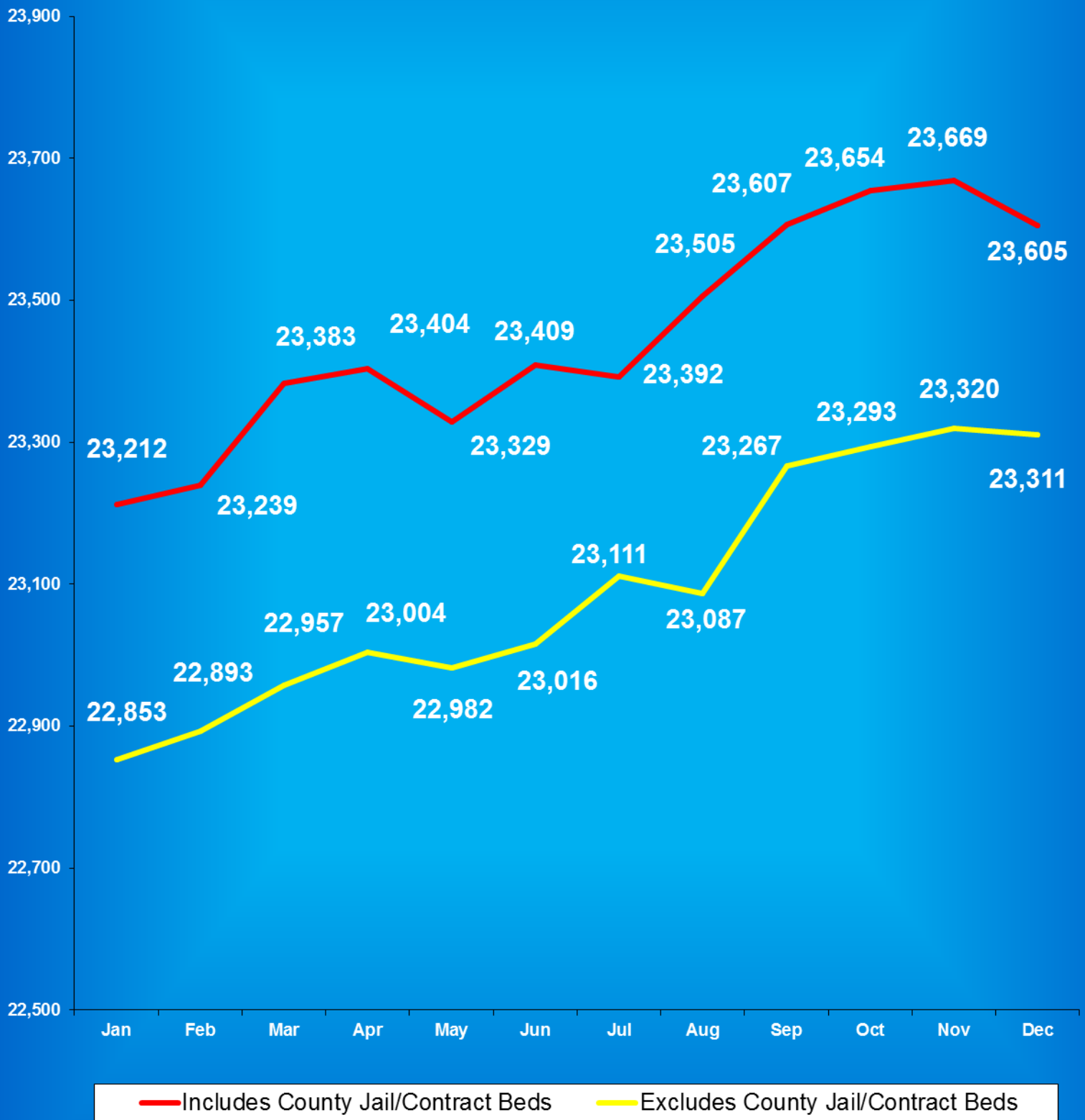

### Average Daily Adult Male Offender Populations Calendar Year 2017

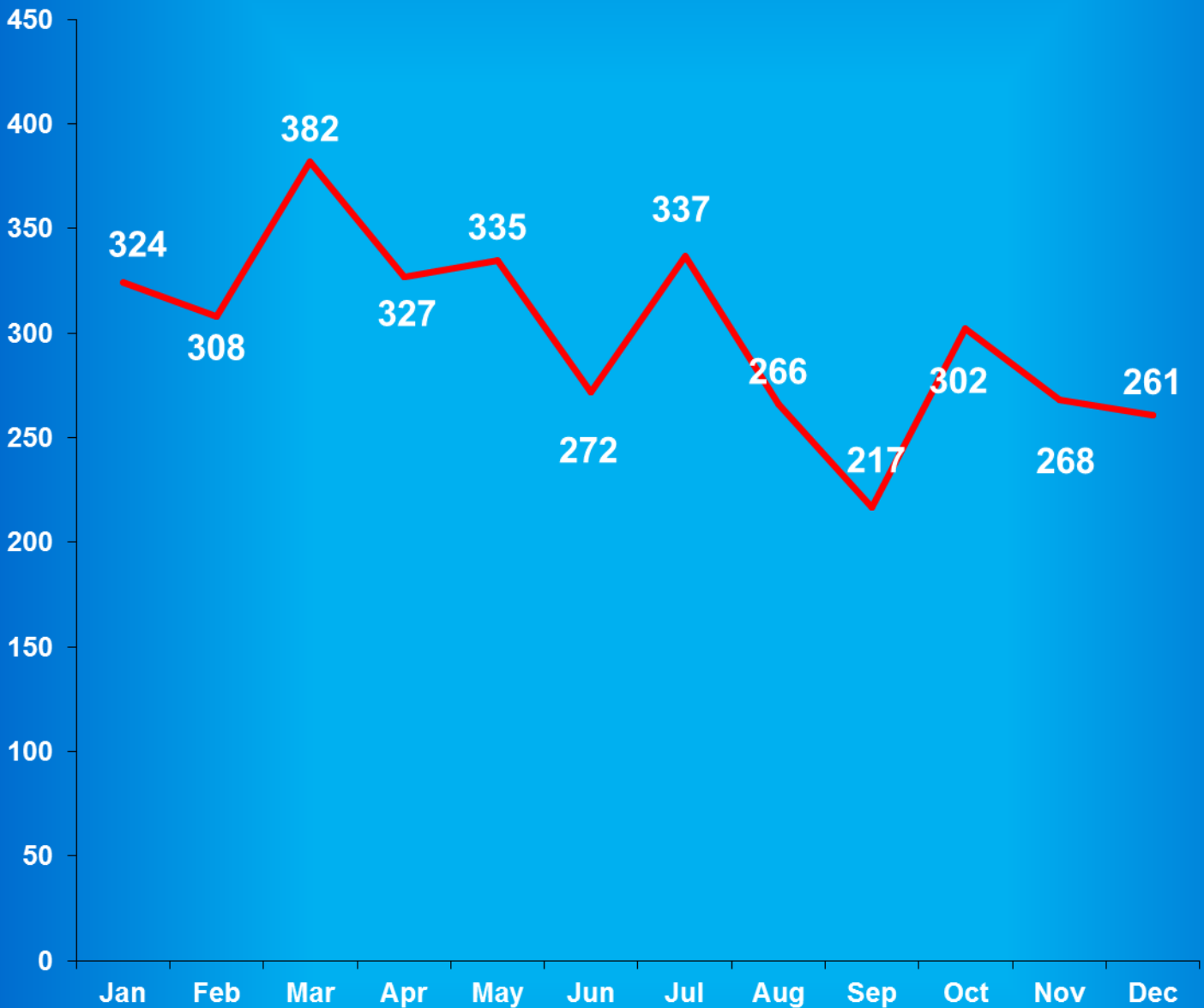

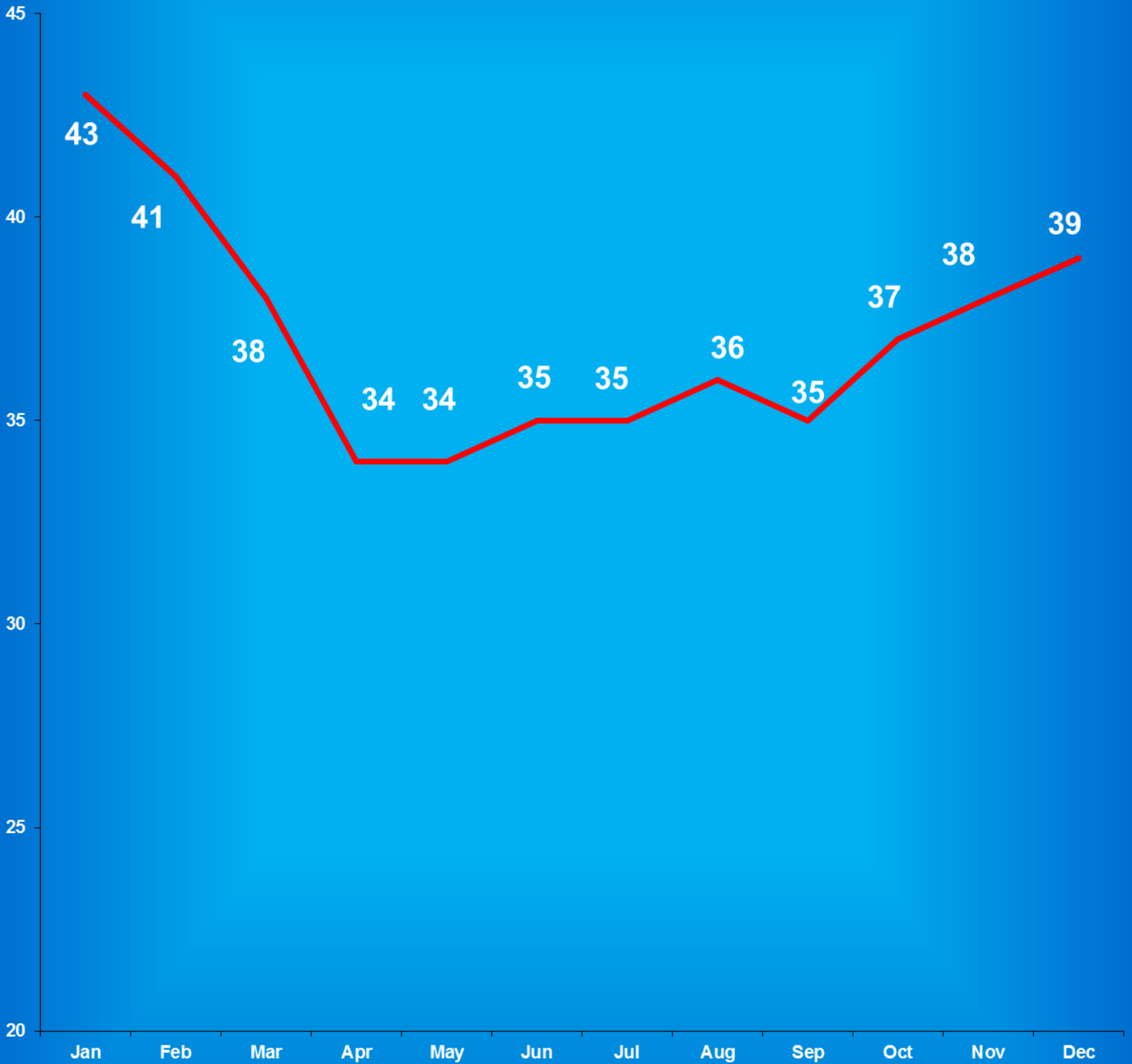

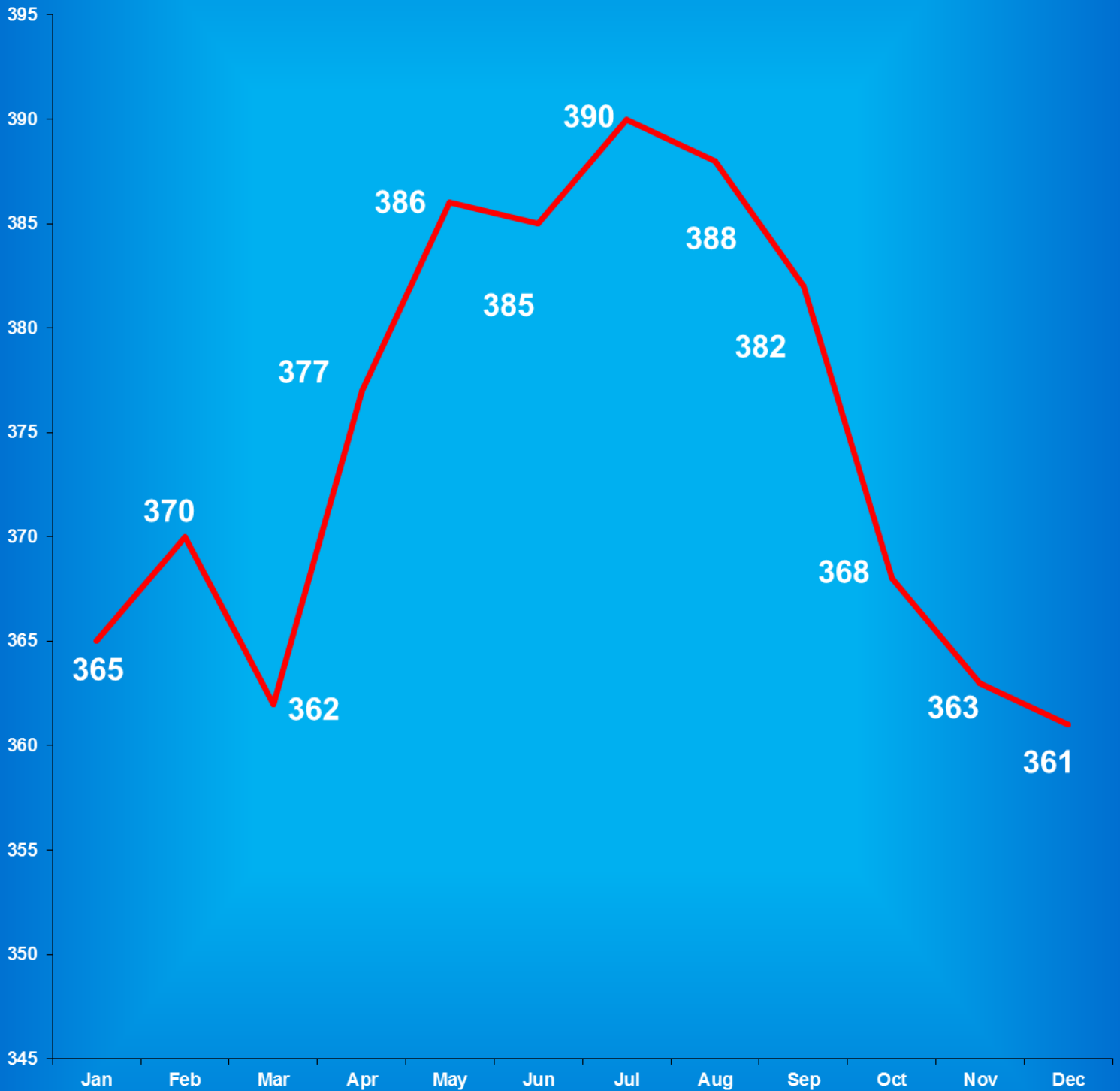
