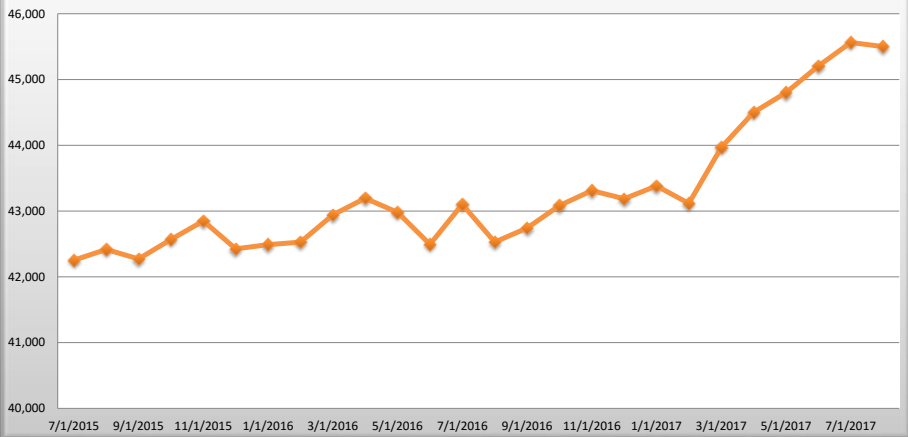

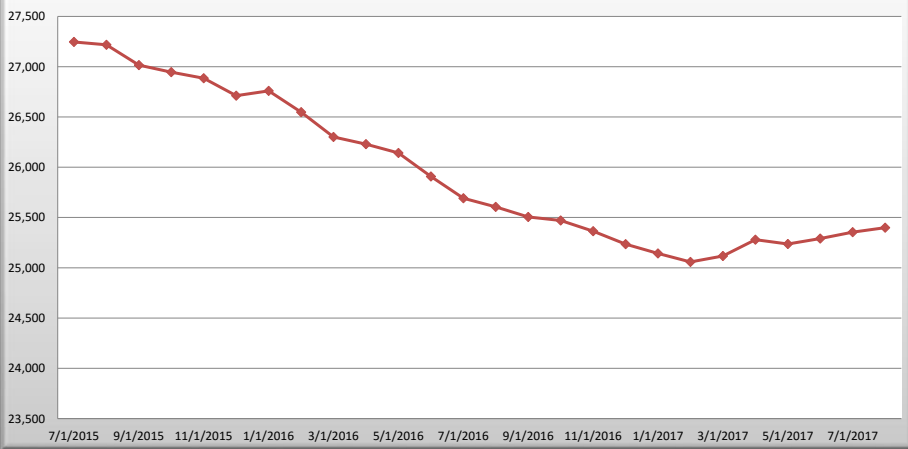

Total Population Trend

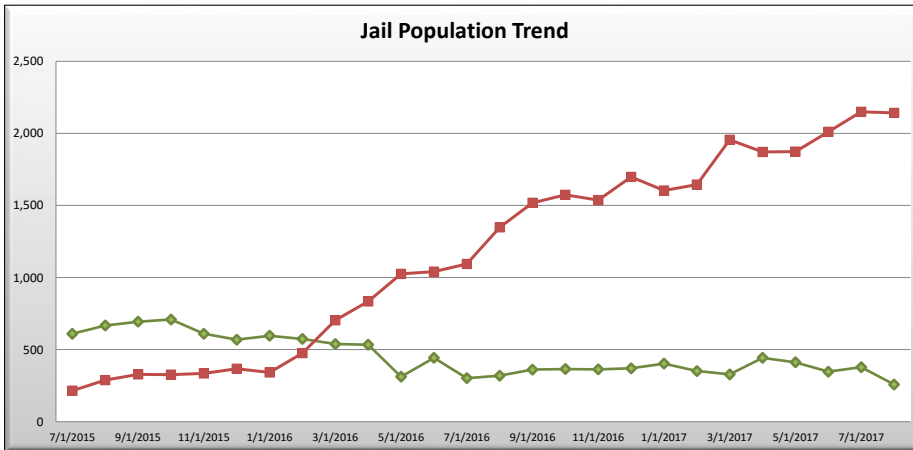
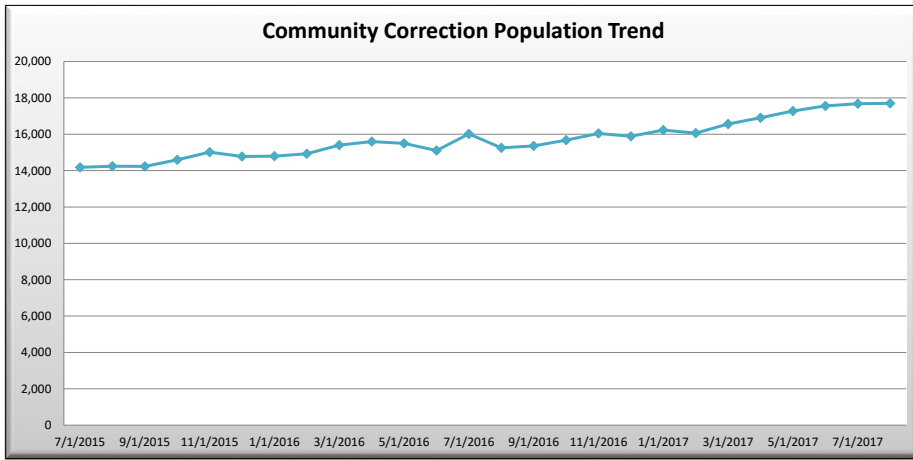


DOC Population Trend
