The names of offenders who have parole or clemency hearings during **September 2018** appear on the attached news release. The names of parole violators are still being assembled and do not appear on the news release. An agenda will be posted at each day’s hearing.

All hearings and meetings (except for executive sessions) are open to observers to the extent that space exists. Hearings labeled “**public**” are to receive information from the public; and the other hearings are to receive information from the offender.
