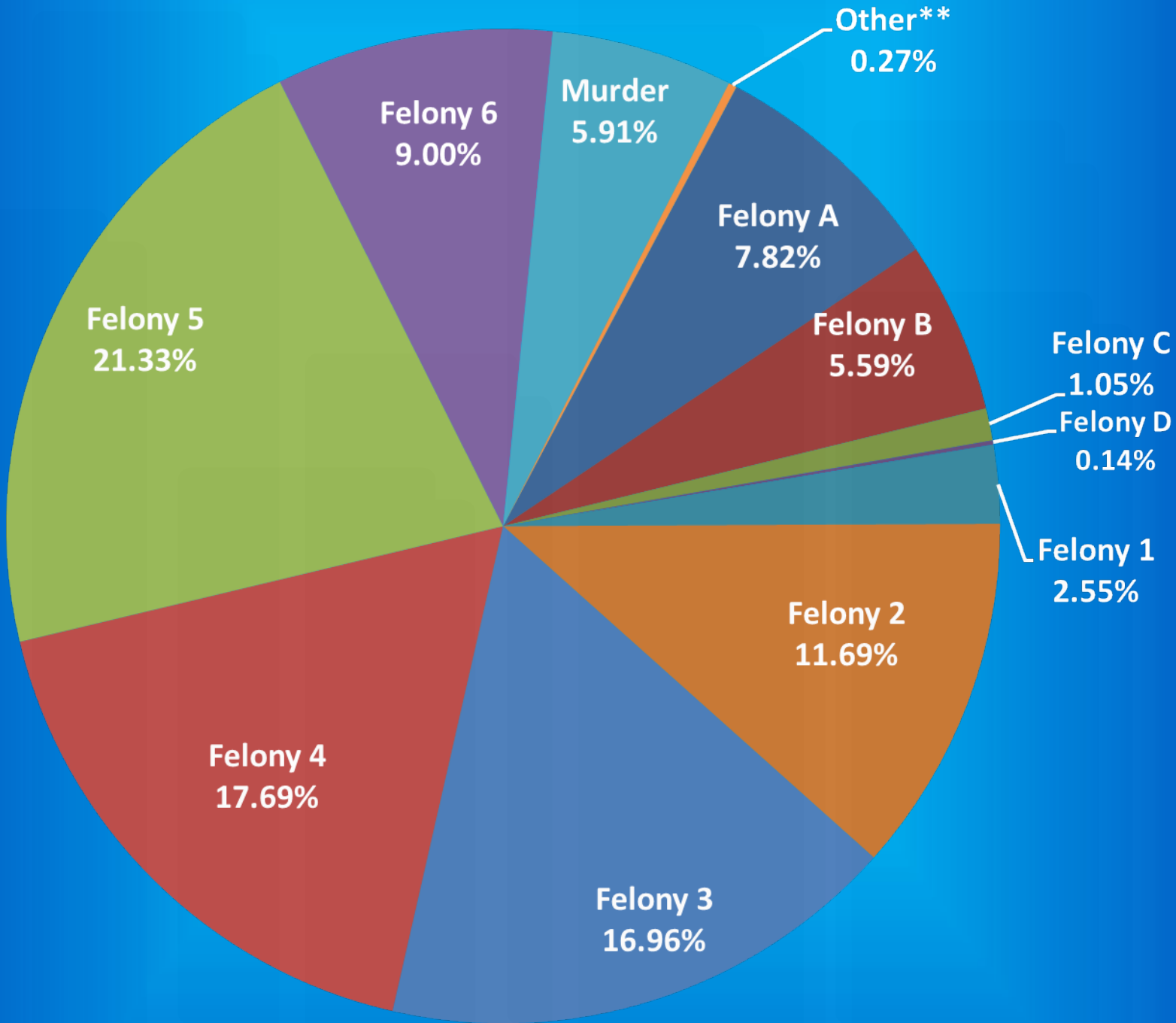

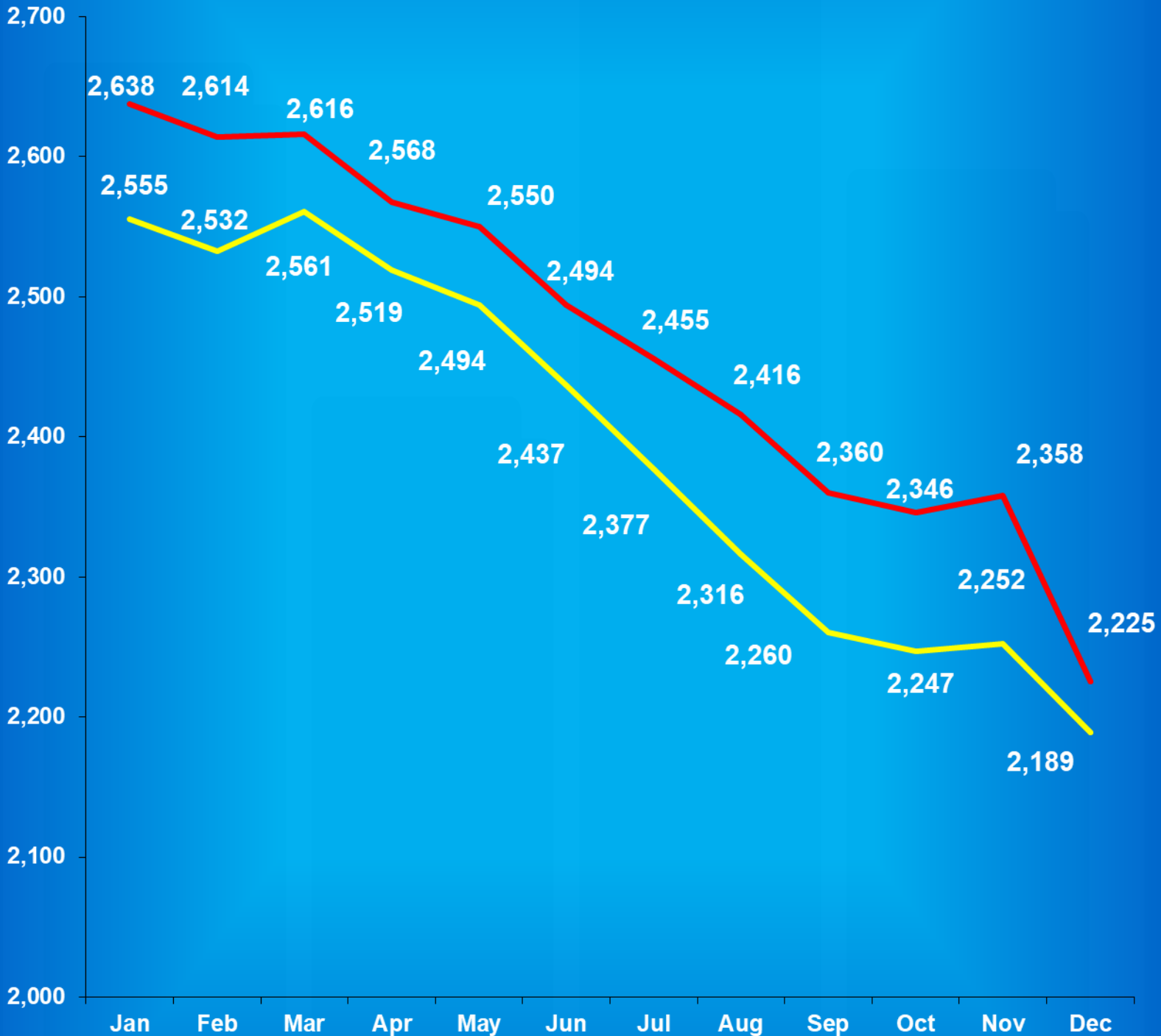

Average Daily Adult Female Offender Populations Calendar Year 2020

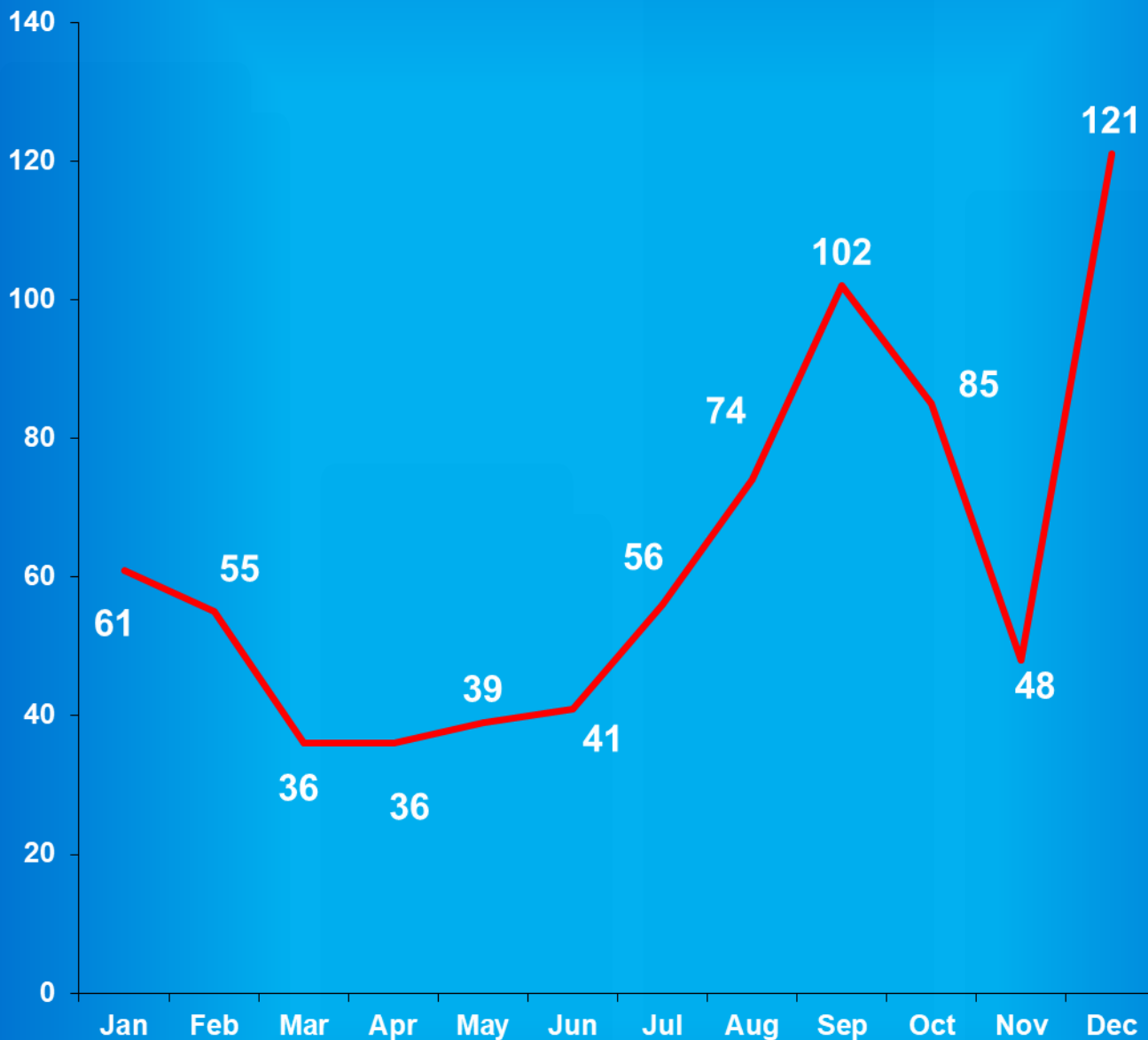

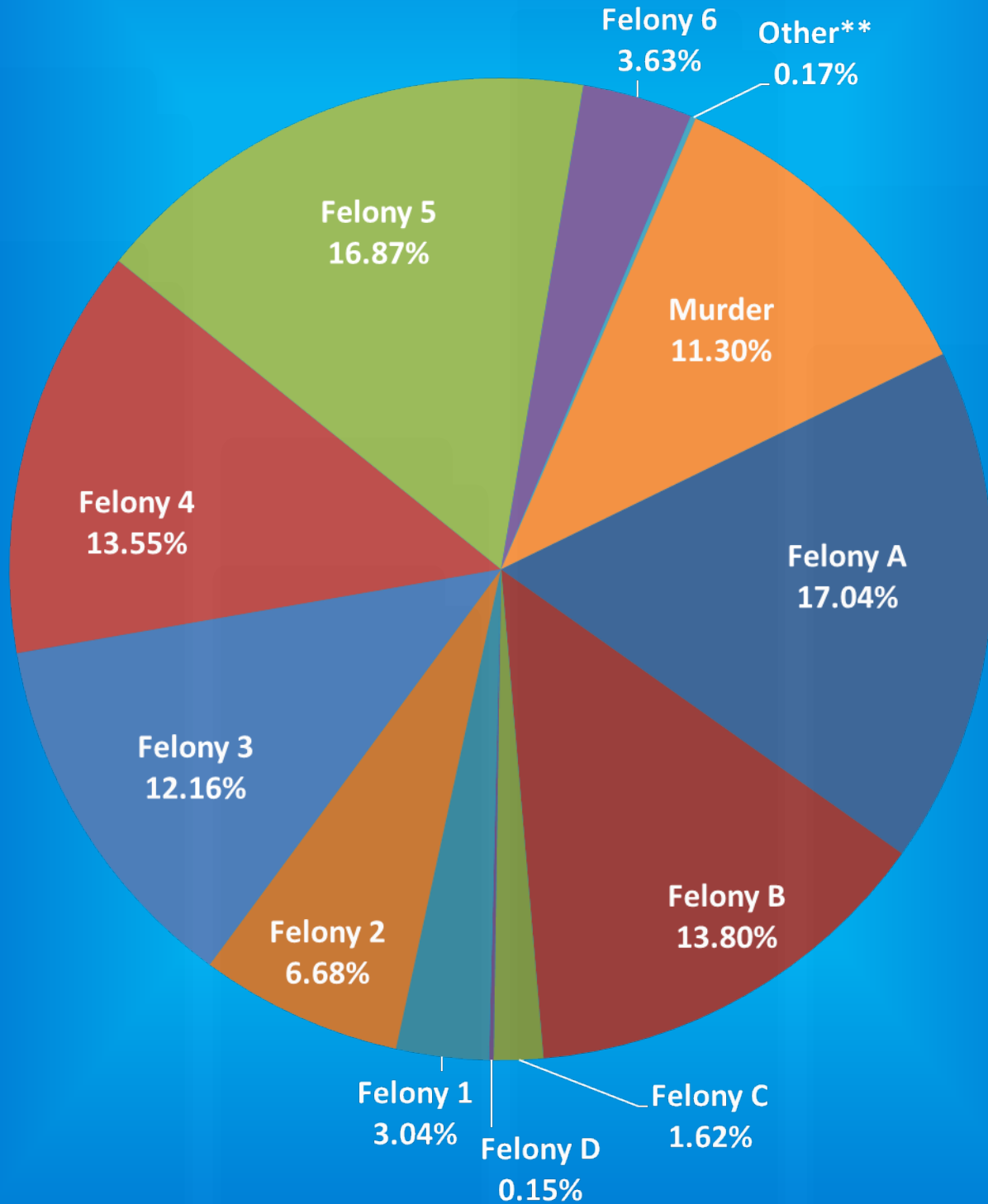

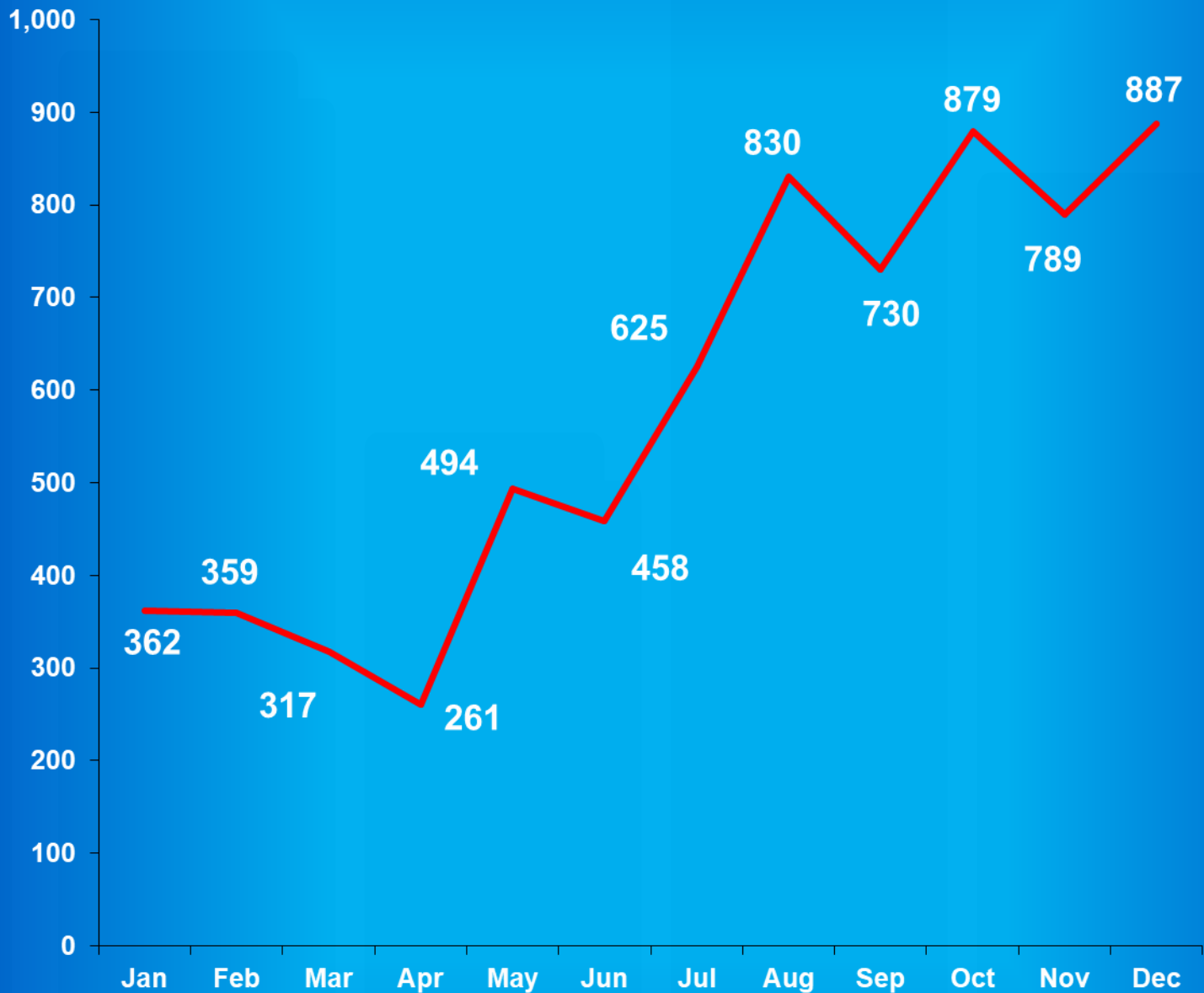
Average Daily Adult Male Offender Populations Calendar Year 2020

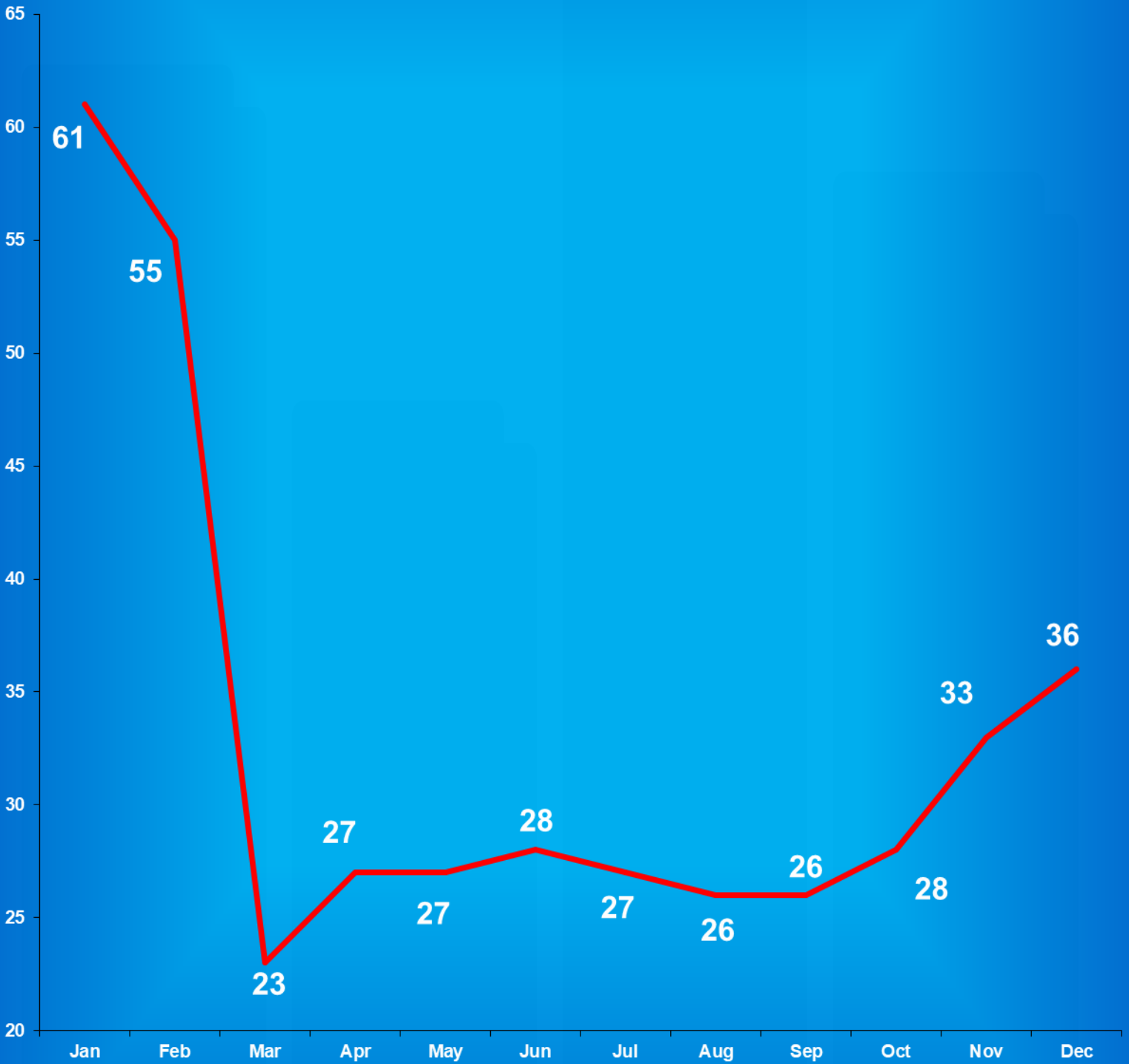

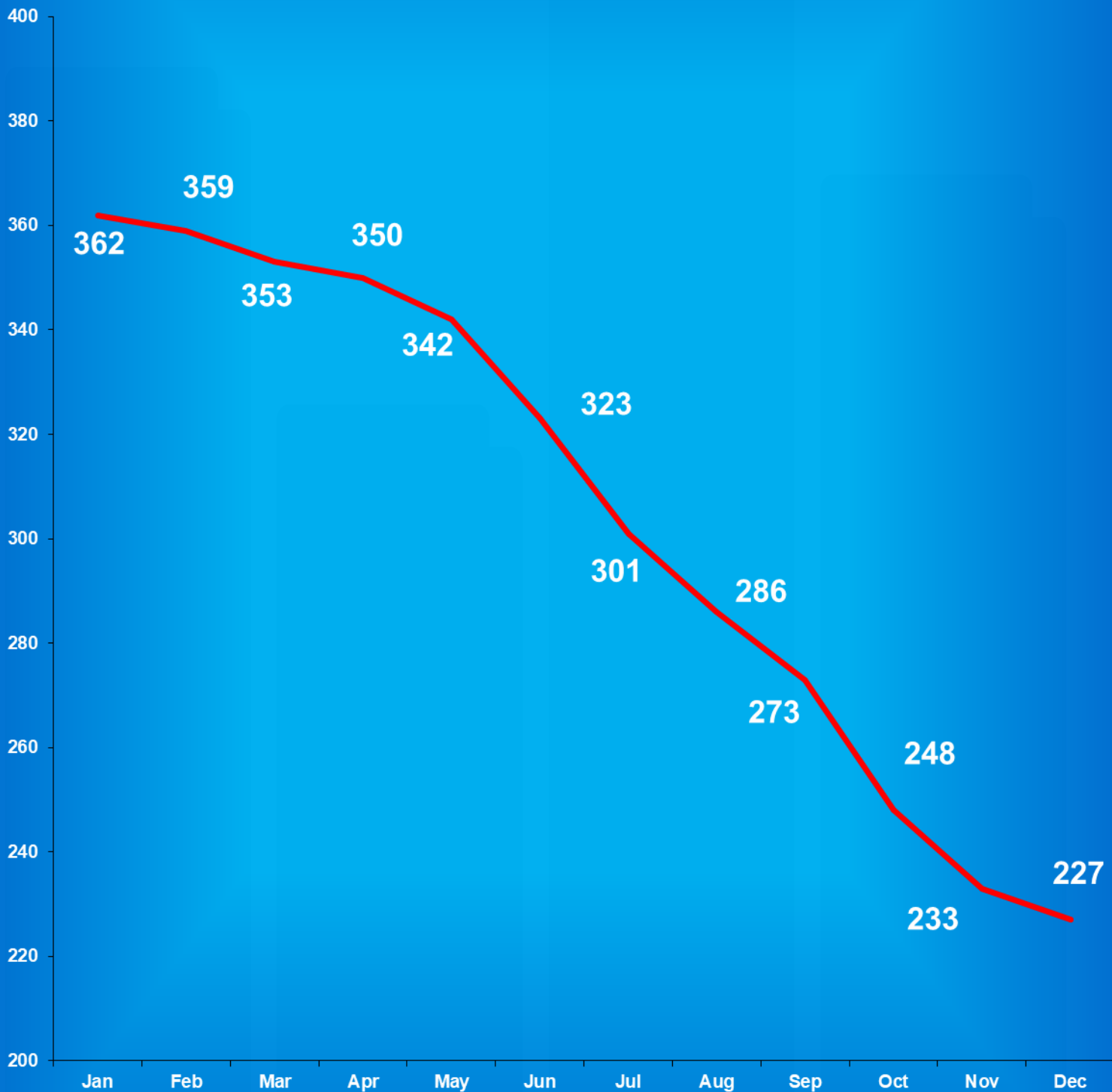
