At Miami Correctional Facility, visits are currently only available on Thursdays, Fridays, Saturdays, and Sundays for the general population. Visits for Restricted Housing Units (RHU / AHU) are scheduled on Wednesdays only.

Scheduled times listed below:

8:00am-9:00am

9:30am-10:30am

11:00am-12:00pm

12:30pm-1:30pm

The new visitation rules are as follows and are subject to change:

1. Only 2 visitors per visit which includes children.
2. Visitors will only be allowed to visit once every 14 days.
3. Visitors may have a brief hug or handshake at the beginning and the end of the visit with no other contact throughout the visit.
4. Visitors are allowed to bring in \$30.00 in change to purchase up to 6 items for the incarcerated individual that they are visiting. All food items will be taken to their housing unit at the end of the visit. No food will be consumed in the visit room, and visitors cannot purchase food items for themselves.
5. We still have non-contact visits for the incarcerated individuals in the general population that are not permitted contact visits. No food can be purchased for incarcerated individuals with a non-contact visit.
6. MCA visit schedule remains unchanged.
7. We recommend arriving at the facility 15-30 minutes prior to your scheduled visit time. If you show up 15 minutes or more late, your visit will be cancelled.
8. Leave your CELL PHONE, purse, wallet locked in your car (less is best) ...the only thing you need to bring in is your driver's license or birth certificate for children, your keys, and you may bring in up to \$30 in coins for the vending machines. Your vehicle is to always remain secured while inside the building.
9. All visitors should wear clothing that reflects acceptable standards which possess no threat to the security, custody, or maintenance of order of the facility. Clothing of the acceptable type should be loose fitting...not form or tight fitting. Clothing can cause the visit to be cancelled. Tight fitting clothes such as stirrup, Lycra pants, or leggings shall not be worn. No Hoodies. Recommend having an extra set of clothes such as sweatpants, T-shirt and tennis shoes are always good alternatives to keep in your vehicle just in case your clothing is considered not acceptable.

10. Dresses, skirts, or shorts must be no shorter than two (2) inches above the knee and not have deep slits.
11. Halter tops, low-cut revealing tops, tank tops, tube tops, sleeveless or cutoffs, see-through, swimsuit tops, body suits, sheer blouses or upper garments reflecting similar dress are STRICTLY PROHIBITED. All visitors must wear a shirt/blouse with sleeves.
12. Heavy coats, sweaters used as outer clothing or other clothing considered heavy outer clothing will not be permitted in the Visiting Room. Suit or sport coats, sweat jackets, sweaters, vests, etc., are permitted, if Visitor Processing staff can inspect and search them or by sending the garment through the x-ray machine. The garment must be worn by the visitor and shall not be removed at any time during the visit.
13. If you wear jeans, you cannot have any rips or holes in your jeans or clothing.
14. No clothing advertising any type of drug paraphernalia or drugs, tobacco, or alcohol is allowed. Hats or other head covering are not permitted, except as required by religious beliefs or medical issues.
15. Undergarments must always be worn. No underwire or wire clasps in your bra or you will not pass the Metal Detector. A sports bra is a great alternative! If you cannot pass the metal detector the first time, your visit will be cancelled.
16. Shoes must be worn, except for infants who are carried.
17. No jewelry, except a wedding band or set, may be worn in the visit room.
18. You must provide medical documentation for any artificial joints and medical issues such as a pacemaker, walker, wheel chair, oxygen, etc.
19. No body piercings. All must be removed before entering Visitor Processing. Medical documentation is required for any dermal piercings that cannot be removed.
20. Incarcerated individuals are required to wear only state-issued clothing which includes blue pants, blue shirt, white t-shirt, white boxers, and white socks. Thermal top and bottoms can be worn from October 15 – April 15. Grey sweatshirts, sweatpants, black shorts, etc. are NOT allowed in the visit room. NO jewelry is allowed in the visit room except for a wedding band...no exceptions even for religious jewelry.
