Likewise, during random and targeted interviews with a sample of inmates, inquiries were made regarding placement in segregation to avoid the risk of victimization by inmates who allege to have suffered sexual abuse during the reporting period. The reason for placement in segregation indicated protective custody was due to factors such as involuntary protective custody-gang related, gambling, or drug debt.</p>

1. Plainfield will submit evidence to support this standard as requested by the Auditor.
2. The PREA Coordinator will provide ongoing oversight in monitoring this standard post-corrective action period.
3. The PREA Coordinator will provide re-training of the PREA Compliance Manager regarding this standard, specifically 115.83 (h).
4. The PREA Coordinator will provide re-training of medical and mental health practitioners regarding this standard. The PREA Compliance Manager and the PREA Coordinator will provide ongoing oversight in monitoring this standard post-corrective action period. The facility will attempt to conduct a mental health evaluation of all known inmate-on-inmate abusers within 60 days of learning of such abuse history and offer treatment when deemed appropriate by mental health practitioners. Compliance will be monitored during the

corrective action period.

Problematic Plainfield omitted evidence of compliance.

115.86 (e): The facility shall implement the recommendations for improvement or document its reasons for not doing so. Problematic Plainfield omitted evidence of compliance.

Corrective Action:

1. Plainfield will submit evidence of compliance through incident reviews and investigations.
2. Additional compliance requirements will be contingent upon the evidence provided by Plainfield.
