115.16 (c): The agency shall not rely on inmate interpreters, inmate readers, or other types of inmate assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the inmate's safety, the performance of first-response duties under § 115.64, or the investigation of the inmate's allegations.

Criminal background records sampled support compliance with this standard.

115.17 (b): IDOC considers any incidents of sexual harassment in determining whether to hire or promote anyone or to enlist the services of any contractor, who may have contact with inmates as confirmed by the HR representative interviewed during the onsite portion of this audit and examination of a sample of criminal background records.

115.17 (c): Confirmed by the HR representative interviewed during the onsite portion of this audit and examination of a sample of criminal background records, before hiring new employees, who may have contact with inmates, the agency shall: (1) Perform a criminal background records check; and (2) Consistent with Federal, State, and local law, make its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse.

Adolescents,” or similarly comprehensive and authoritative protocols developed after 2011.

115.21 (c): IDOC offers all victims of sexual abuse access to forensic medical examinations, whether on-site or at an outside facility, without financial cost, where evidentiarily or medically appropriate according to the PREA Compliance Manager. The forensic examinations are performed by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) where possible. If SAFEs or SANEs cannot be made available, the forensic examination is performed by other qualified medical practitioners. IDOC documents all efforts to provide SAFEs or SANEs to victims of sexual abuse.

115.21 (c)-2 The facility offers all inmates who experience sexual abuse access to forensic medical examinations onsite. CIF indicated in the PAQ as no. Forensic examinations are conducted in a local hospital through emergency services.

115.21 (c)-10 The number of exams performed by a qualified medical practitioner during the past 12 months indicated on the PAQ was zero. During an interview with the PRES Compliance Manager and the PREA investigator this Auditor confirmed that during this reporting period CIF transported zero victims of sexual abuse to a local hospital for a forensic examine.

115.21 (d): For the purpose of this standard, a rape crisis center refers to an entity that provides intervention and related assistance, such as the services specified in 42 U.S.C. 14043g(b)(2)(C), to victims of sexual assault of all ages. The agency may utilize a rape crisis center that is part of a governmental unit as long as the center is not part of the criminal justice system (such as a law enforcement agency) and offers a comparable level of confidentiality as a nongovernmental entity that provides similar victim services. IDOC has a contractual agreement with a victim advocacy organization from a rape crisis center, Alternatives, Inc. If Alternative, Inc., is not available to provide victim advocate services, IDOC makes its best effort to provide advocacy services from a qualified staff member Sexual Assault Response Team (SART).

115.21 (e): By examination of the contractual agreement with Alternatives, Inc., the Auditor determined that if requested by the victim, the victim advocate, qualified agency staff member, or qualified community-based organization staff member shall accompany and support the victim through the forensic medical examination process and investigatory interviews and shall provide emotional support, crisis intervention, information, and referrals.

115.21 (f): IDOC is responsible for investigating allegations of sexual abuse.

115.21 (g): The requirements of paragraphs (a) through (f) of this section shall also apply to: (1) Any State entity outside of the agency that is responsible for investigating allegations of sexual abuse in prisons or jails; and (2) Any Department of Justice component that is responsible for investigating allegations of sexual abuse in prisons or jails. IDOC is responsible for investigating allegations of sexual abuse.

115.21 (h): For the purposes of this section, a qualified agency staff member or a

115.31 (c): Further, the same policy directs all current employees who have not received such training to be trained within one year of the effective date of the PREA standards, and the agency shall provide each employee with refresher training every two years to ensure that all employees know the agency’s current sexual abuse and sexual harassment policies and procedures. In years in which an employee does not receive refresher training. According to random and specialized staff sampled during the onsite portion of this audit all confirmed that IDOC provides refresher information on current sexual abuse and sexual harassment policies. Problematic, CIF omitted evidence to support this standard beyond staff interviews. Corrective action is in order.

115.31 (d): The agency shall document, through employee signature or electronic verification, that employees understand the training they have received. According to random and specialized staff sampled during the onsite portion of this audit all confirmed that IDOC provides refresher information on current sexual abuse and sexual harassment policies. Problematic, CIF omitted evidence to support this standard beyond staff interviews. Corrective action is in order.

1. CIF will provide evidence to support this standard in the form of training document with a sample of specialized and custody staff.
2. Based on evidence provided by CIF will determine if further corrective action is needed.
