### **Indiana to charge retaliatory fees for residents of CA, CT, MA, and NJ**

Effective September 13, 2012, the Indiana Department of Insurance will impose retaliatory fees for residents of California, Connecticut, Massachusetts, and New Jersey who renew an existing non-resident license or apply for a new non-resident license. Applicants with an expiration date of November 30, 2012 or later will be affected by the new fees. Retaliatory fees are already in effect for residents of Illinois.
