## PUBLIC NOTICE OF LIQUIDATION

Attention: All persons interested in Geneva Insurance Company ("Geneva") including holders of its insurance policies, and all other persons who may have a claim against Geneva; Geneva 's former officers and directors; any corporation affiliated with Geneva; producers of Geneva; parties or their counsel of record in pending or threatened litigation and claims involving Geneva; creditors of Geneva; and any banks or other financial institutions that do business with Geneva.

PLEASE READ THIS NOTICE CAREFULLY. IT DESCRIBES IMPORTANT RIGHTS YOU OR YOUR ORGANIZATION MIGHT HAVE AND WHERE YOU CAN OBTAIN ADDITIONAL INFORMATION CONCERNING GENEVA, AND YOUR POTENTIAL RIGHTS IN CONNECTION WITH ITS LIQUIDATION.

This Notice is issued in accordance with Indiana Code 27-9, and pursuant to the order of the Marion Circuit Court located in Indianapolis, Indiana ("Liquidation Court"), with respect to the liquidation of Geneva, an Indiana insurance company.

On July 8, 2019, the Liquidation Court entered a final order of liquidation against Geneva ("Order of Liquidation"). The Order of Liquidation found and concluded that Geneva should be liquidated, terminated the rehabilitation proceeding that was then pending against Geneva, and appointed the Indiana Insurance Commissioner and his successors in office as liquidator of Geneva ("Liquidator"). The Liquidation Court directed the Liquidator to take possession of the assets of Geneva and to administer them under the Liquidation Court's supervision. The Liquidator is vested by operation of law with title to all of the property, contracts, and rights of action of Geneva, wherever located.

The Liquidation Court has established <u>June 30, 2021</u> as the date after which claims against Geneva will be barred. If you would be reasonably expected to have a claim against Geneva, or if you have asserted a claim against Geneva, and if Geneva has your current address, you should have received or shortly will receive a separate notice about your policy or your other potential claim against Geneva from the Liquidator, or from your insurance agent.

No action at law or equity may be brought against Geneva or the Liquidator, whether in Indiana or elsewhere, nor shall any existing actions be maintained or further presented, pursuant to Ind. Code 27-9-3-12. All claims against Geneva must be asserted by filing a Proof of Claim in the liquidation proceeding.
