- 7. The Department will not seek further penalties against Respondents, but will cooperate with any criminal investigation that has been, or may be, initiated as a result of the allegations in this matter.

- 8. The Department agrees to accept Respondents' compliance with the terms of this Agreed Entry as full resolution of this matter.
- 9. Respondents are aware that failure to comply with any term of this agreement will result in the matter being set for hearing.
- 10. Respondents have carefully read this agreement and fully understand and accept its terms.
