

1. Respondent will pay an administrative fine in the amount of two thousand five hundred dollars (\$2,500.00) within thirty (30) days of the filing of this Final Order.

2. The Department agrees to accept Respondent's compliance with the terms of this Order as full and final resolution of issues in enforcement case E-6252.

WHEREAS, Respondent is an insurance company with a statutory home office located in the State of Arizona and licensed to do business in the State of Indiana; and


WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.

5. Conseco Health Insurance Company handling of a claim under the complainant's family Cancer policy Return of Premium Rider did not comply with Indiana Code Section 27-4-1-4.5(2).
6. Respondent agrees to pay an administrative fine in the amount of two thousand five hundred dollars (\$2,500.00) within thirty (30) days of the filing of the Commissioner's Final Order.
7. The Department agrees to accept Respondent's compliance with the terms of this agreement as full and final resolution of issues in enforcement case E-6252.
8. Respondent has carefully read and examined this agreement and fully understands its terms.
